**PROVINCIAL NOTICE 39 OF 2019****NOTICE BY THE PREMIER OF LIMPOPO****REMUNERATION OF PUBLIC OFFICE BEARERS ACT, 1998 (ACT NO. 20 OF 1998)****DETERMINATION OF THE UPPER LIMIT OF SALARIES AND ALLOWANCES OF  
MEMBERS OF THE EXECUTIVE COUNCIL AND MEMBERS OF THE LIMPOPO  
PROVINCIAL LEGISLATURE OF 2018/2019**


The President having determined the upper limit of salaries and allowances of members of Executive Councils and members of provincial legislatures in Proclamation No. 39 of 2018 in *Government Gazette* No. 42107 dated 13<sup>th</sup> December 2018 ("the Proclamation by the President")—:

1. I, Chupu Stanley Mathabatha, having regard to the Proclamation by the President and acting in terms of Section 6(3) (a) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) hereafter referred as ("the Act"), hereby determine that the upper limit of salaries of the positions of office bearers in Column 3 of Schedule 1 shall be as set out in Column 4 of Schedule 1 with effect from 01 April 2018, subject to the provisions of section 6(2) - (8) of the Act, and the terms and conditions set out herein.
2. The total remuneration packages shall include the following elements:
  - 2.1 A basic salary component equal to 60% of the total package, which constitutes the pensionable salary;
  - 2.2 An amount of R120 000 per annum, which is an amount to which section 8(1) (d) of the Income Tax Act, 1962 applies. This amount is included in the basic salary component;
  - 2.3 An employer's pension benefit contribution equal to 22.5 % of pensionable salary; and

2.4 A flexible portion for the remaining amount of the total remuneration.

3. Provincial Notice No. 125 of 2017 published in the *Limpopo Provincial Gazette* No. 2871 on the 20<sup>th</sup> December 2017 is hereby repealed.
