Intends submitting an application to the Limpopo Gambling Board for the LPM Site Operator Licence on **08 August 2019**.

The purpose of the application is to obtain a LPM Site operator licence in the Province of Limpopo.

If successful the duration of the licence is in perpetuity subject to continuous suitability.

The application will be open for public inspections for 30 days at the office of the Limpopo Gambling Board at 08 Hans van Rensburg Street, Polokwane, Limpopo Province, South Africa, from **08 August 2019**.
