Notice is hereby given that Phumelela Gaming & Leisure t/a TAB intends to submit the application to Limpopo Gambling Board for removal of the TAB Agency Licence, in terms of Section 38 of the Limpopo Gambling Act 3 of 2013, on 04 June 2021.

The purpose of the application is to obtain permission to relocate the Mopani TAB Agency Licence from No 365 Main Road, Steelpoort to Jorge Business Park (Building opposite Steelpoort Sasol Garage), 315 KT, Remainder of Portion 5 of Olifantspootjies Farm, R555 Road, Steelpoort, Limpopo Province.
