#### LOCAL GOVERNMENT: MUNICIPAL DEMARCATION ACT, 1998

#### RE-DETERMINATION OF MUNICIPAL BOUNDARIES: DETERMINING OF EFFECTIVE DATE IN TERMS OF SECTION 23 (2) (b) OF LOCAL GOVERNMENT: MUNICIPAL DEMARCATION ACT, 1998 AND SECTION 6 (3) (b) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998

Under the powers vested in me by section 23 (2) (b) of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998) and section 6 (3) (b) of the Local Government; Municipal Structures Act, 1998 (Act No. 117 of 1998) I, Kwati Candith Mashego-Dlamini, Member of the Executive Council responsible for Local Government and Housing in the Mpumalanga Province, hereby determine that re-determination of the municipal boundaries of municipalities as indicated by the Municipal Demarcation Board in the notices published in the Mpumalanga Provincial Gazettes, and on the dates set out in the Schedule hereto, and after the Independent Electoral Commission's Notice No 1569 published in the Mpumalanga Provincial Gazette Extraordinary dated 11 August 2008. Notice No.1569 takes effect at the next Local Government elections in 2011 on the date to be determined by the Independent Electoral Commission.
