### PROPOSED AMENDMENT OF PARAGRAPH 6 OF PART 3 OF THE SCHEDULE OF NOTICE NO.127 OF 2006

#### COUNCILLORS

6. The council of the Victor Khanye Local Municipality consists of 7 proportionally elected councillors and 8 ward councillors as determined in Provincial Notice No. 5 of 28 April 2000. The council of the local municipality may designate the following office bearers as full- time:

- (a) Speaker;
  - (b) Executive Mayor; and
  - (c) 2 Members of the Mayoral Committee; **[and]**
  - (d) **[A Whip]**.
