An invitation is hereby made in terms of Section 78(2) of the Act that every person who wishes to lodge an objection in respect of any other matter in, or omitted from the supplementary roll, shall do so within the above mentioned period with the Municipal Manager.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the supplementary valuation roll as such. The completed form must be returned to the Municipal Manager by post to P.O. Box 14, Middelburg, 1050 or delivered by hand at the Department: Legal and Administration, Room C301, Second Floor, Municipal Building, Corner Wanderers Avenue and Walter Sisulu Street, Middelburg by no later than 01 April 2011 at 13h00.
