NOTICE OF A MERGER OF WATERVAL BOVEN FET CAMPUS WITH NKANGALA FET COLLEGE

Definitions

In the Schedule unless the content indicates otherwise, expressions defined in the Act have the same meaning, and:

1. **“Act”** means the Further Education and Training Colleges Act (Act No.16 of 2006).
2. **“Member of the Executive Council”** means Member of the Executive Council for Education for the Province of Mpumalanga.
3. **“College”** means a public or private further education and training Institution that is established, declared or registered under this Act, but does not include-
 - a) a school offering further education and training programmes under the South African Schools Act; or
 - b) a college under the authority of a government department other than the Department of Education.

SCHEDULE

I, MAKGABO REGINAH MHAULE, in my capacity as Member of the Executive Council responsible for Education in Mpumalanga, having complied with the provisions of section 6(2)(a-d) of the Further Education and Training Colleges Act No. 16 of 2006, hereby give notice in terms of Section 6(1) of the act, of the merger of Waterval Boven Campus of Ehlanzeni FET College with Nkangala FET College scheduled to take effect on the 1st of April 2011. The merger is informed by the jurisdictional placement of Waterval Boven campus which is within the borders of Nkangala Municipal District, but is under the administration of Ehlanzeni FET Colleges which falls within the borders of the Ehlanzeni Municipal District.
