LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998


AMENDMENT OF SECTION 12 NOTICE IN TERMS OF SECTIONS 16(1)(g) AND 17 OF LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998

I, Madala Backson Masuku, Member of the Executive Council responsible for local government in the Province of Mpumalanga, in terms of section 16(1)(g) read with section 17(1) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), and with effect from the date of the next election of municipal councils scheduled for 18 May 2011, hereby -

- (a) include a portion of the area of the Ehlanzeni District Management Area (MPDMA 32) into the –
- (i) Mbombela Local Municipality;
 - (ii) Nkomazi Local Municipality; and
 - (iii) Bushbuckridge Local Municipality.
- (b) amend clause 4 of Provincial Notice 125 of 2006 published in *Provincial Gazette* No 1317, to give effect to the change in the boundary of the Mbombela Local Municipality (MP322) as contemplated in Municipal Demarcation Board Notice No.1022 published in *Government Gazette* No.31353 dated 19 August 2008 and confirmed by the Independent Electoral Commission in Government Notice No. 320 published in *Government Gazette* No.1569 dated 11 August 2008;
- (c) amend clause 4 of Provincial Notice 125 of 2006 published in *Provincial Gazette* No 1317, to give effect to the change in the boundary of the Nkomazi Local Municipality (MP 324) as contemplated in Municipal Demarcation Board Notice No. 1022 published in *Government Gazette* No.31353 dated 19 August 2008 and confirmed by the Independent Electoral Commission in Government Notice No. 320 published in *Government Gazette* No 1569 dated 11 August 2008;

- (d) amend clause 4 of Provincial Notice 125 of 2006 published in *Provincial Gazette* No 1317, to give effect to the change in the boundary of the) Bushbuckridge Local Municipality (MP 325) as contemplated in Municipal Demarcation Board Notice No. 1022 published in *Government Gazette* No. 31353 dated 19 August 2008 and confirmed by the Independent Electoral Commission in Government Notice No. 320, published in *Government Gazette* No.1569 dated 11 August 2008;
- (e) determine that the Mbombela Local Municipality (MP 322) Nkomazi Local Municipality (MP 324) and Bushbuckridge Local Municipality (MP325) become the successor-in-law of the Ehlanzeni District Municipality as far as it relates to that that portion of the Ehlanzeni District Management Area (MPDMA 32) that has been included in the aforementioned local municipalities in terms of paragraphs (a) to (d).
