Notice is hereby given in terms of Section 49(1)(a)(i) read together with Section 78(2) of the Local Government: Municipal Property Rates Act, 2004 (Act No 6 of 2004), hereinafter referred to as the "Act", that the Supplementary Valuation Roll for the financial years 2011/2012 is open for public inspection at the Govan Mbeki Municipal Offices, Horwood Street, Secunda at rooms 216, 218, 220 and 224 as well as at the pay points in Bethal, eMbalenhle and Leandra during normal office hours from 20 April 2012 to 22 May 2012. Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the Supplementary Valuation Roll as such.
