

REQUEST FOR PROPOSALS FOR A CASINO LICENCE IN THE MPUMALANGA PROVINCE

The purpose of this notice is to inform interested parties that intend to submit preliminary proposals for a casino licence in terms of the Request for Proposal (RFP) for a casino licence in the Mpumalanga Province that the revised B-BBEE Codes of Good Practice (Codes), published on 11 October 2013, must be used for purposes of the aforementioned preliminary proposals.

Interested parties are no longer required to submit a projected B-BBEE scorecard, as per clause 1.5.5 of the RFP. It should be noted that evaluations will be conducted in line with the RFP by utilising the matrix that can be obtained at: www.mgb.org.za.
