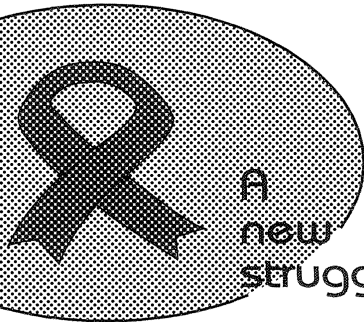

**MPUMALANGA LIQUOR LICENCING ACT, 2006
(ACT NO. 5 OF 2006)**

In terms of section 69(2) of the Mpumalanga Liquor Licencing Act, 2006, I, **David Dabede Mabuza**, in my capacity as Premier of the Mpumalanga Province, hereby determine **30 August 2014**, as the date for the coming into operation of sections 33 to 68 of the said Act.

It is hereby confirmed that the Mpumalanga Liquor Licencing Act, 2006 (Act No. 5 of 2006), was duly, in terms of section 121 of the Constitution of the Republic of South Africa, 1996 assented to by the then Premier of Mpumalanga, on 7 May 2007.

Sections 1 to 32 and 69 of the Mpumalanga Liquor Licencing Act, 2006, were put into operation by means of a Premier's Notice published in *Provincial Gazette Extraordinary* No. 1710, on 12 August 2009.
