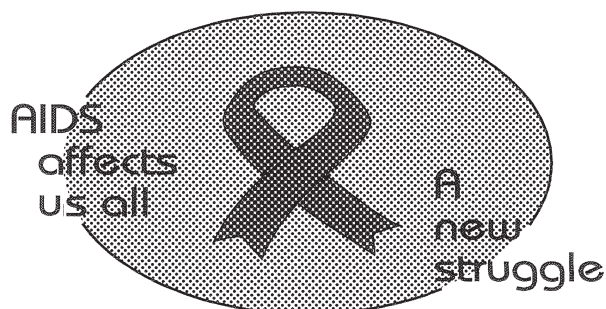

## CALL FOR NOMINATIONS TO SERVE ON THE MPUMALANGA GAMBLING BOARD

I, Sikhumbuzo Eric Kholwane (MPL), Member of Executive Council responsible for the administration of the Mpumalanga Gambling Act (Act 5 of 1995) as amended, hereby invite nominations for persons to be evaluated and appointed to fill vacancies in the Mpumalanga Gambling Board.

Candidates to be nominated shall have sufficient knowledge and understanding of the gambling industry, as well as the legislation pertaining to the functions of the Board.

In terms of section 5 (1) of the Mpumalanga Gambling Act, 1995, a person shall not be appointed or remain a member of the Board-

a) Unless he or she -

- i) is a natural person;
- ii) is a citizen of the Republic and an ordinary resident therein;
- iii) is a fit and proper person; and
- iv) has never been convicted, whether in the Republic or elsewhere, of theft, fraud, forgery or uttering a forged document, perjury, an offence under the Corruption Act, 1992(Act No. 04 of 1992), or any offence involving dishonesty or of an under this Act or any other similar law.

When nominations are made, it must be taken into consideration that the following vacancies exist in the Board: -

- one member who is a qualified Chartered Accountant in the Republic and has for a cumulative period of least five years so qualified practised;
- with due regard to regional interests in the Province, three members who reside and/or are domiciled within the Gert Sibande, Nkangala and Ehlanzeni District Municipalities-

All submissions for nominations must include a brief curriculum vitae of the nominee as well as a sworn/confirmed statement by each individual declaring that such candidate has no financial interest, whether directly or indirectly, in the gambling industry.
