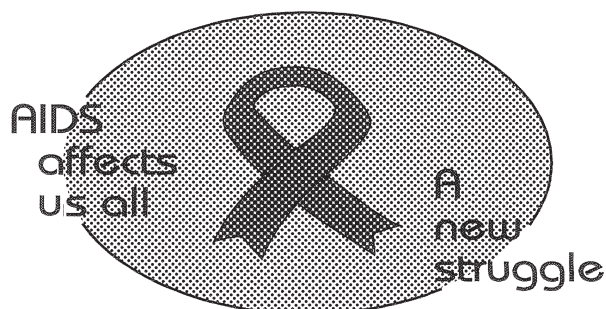

National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.

All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.

7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. The council of Emakhazeni Local Municipality has in terms of **resolution number S01/06/2015** approved the assessment rates for the financial year 2015/2016. Council has in terms of **resolution number 24/07/2015** reaffirmed the categories and tariffs as set out in the municipal budget thereby amending and setting aside incorrect tariffs published in the Provincial Gazette number 2508 as follows:

#### Cents per R 1.00

#### CATEGORY: 2015/2016

Residential with the exclusion of the first R15 000 of assessed 0.0072 applicable to properties with a market value including government owned market value of R 100,000.00 and more.

For properties less than R 100,000.00 market value a flat rate of R 680.00 per year (R56.67per month) will be charged.
