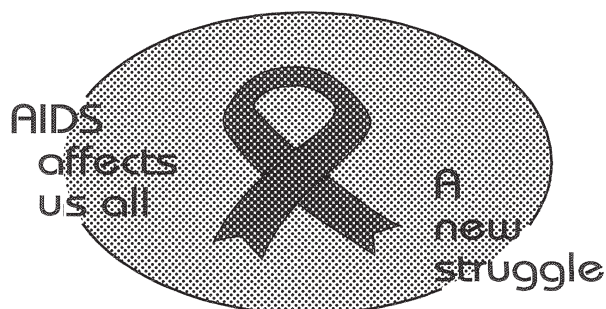

GPW Business Rules

This means that any notice submissions not on an Adobe electronic form that are submitted to this mailbox will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines – www.gpwonline.co.za)
7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email info.egazette@gpw.gov.za)
8. All re-submissions by customers will be subject to the above cut-off times.
9. All submissions and re-submissions that miss the cut-off will be rejected to the customer to be submitted with a new publication date.

PROVINCIAL NOTICE 48 OF 2015**NOTICE TO CLOSE PERDEKOP AGRICULTURAL SCHOOL**

By virtue of the power vested in me in terms of Section (33)1) of the South African Schools Act (Act 84 of 1996) I, Makgabo Reginah Mhaule, being Member of the Executive Council responsible for Mpumalanga Department of Education, hereby publish a notice to close Perdekop Agricultural School EMIS NO 800017996 located in the Gert Sibande District .

The closure of the school will take effect in phases which will begin in 2016 when grade 8 will be phased out. This will be followed by a logical phasing out of subsequent grades until the last grade 12 in 2019.

The Gert Sibande TVET College from 2016 will phase in their courses as all assets owned by the school will be transferred to the college in terms of the Act.

The Mpumalanga Department of Education will continue funding the school on the basis of its enrolment and running costs and the School Governing Body is expected to continue its duties until the last group of students leave the school.
