

Government Printing Works Notice submission deadlines

Government Printing Works has over the last few months implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submit your notice request.

In line with these business rules, GPW has revised the notice submission deadlines for all gazettes. Please refer to the GPW website <u>www.gpwonline.co.za</u> to familiarise yourself with the new deadlines.

CANCELLATIONS

Cancellation of notice submissions are accepted by GPW according to the deadlines stated in the table above. Non-compliance to these deadlines will result in your request being failed. **Please pay special attention to the different deadlines for each gazette**.

Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.

Requests for cancellation must be sent by the original sender of the notice and must accompanied by the relevant notice reference number (N-) in the email body.

AMENOMENTS TO NOTICES



With effect from 01 October, GPW will not longer accept amendments to notices. The cancellation process will need to be followed and a new notice submitted thereafter for the next available publication date.

CUSTOMER INQURIES

Many of our customers request immediate feedback/confirmation of notice placement in the gazette from our Contact Centre once they have submitted their notice – While GPW deems it one of their highest priorities and responsibilities to provide customers with this requested feedback and the best service at all times, we are only able to do so once we have started processing your notice submission.

GPW has a <u>2-working day turnaround time for processing notices</u> received according to the business rules and deadline submissions.

Please keep this in mind when making inquiries about your notice submission at the Contact Centre.

PROOF OF PAYMENTS REMINDER

GPW reminds you that all notice submissions **MUST** be submitted with an accompanying proof of payment (PoP) or purchase order (PO). If any PoP's or PO's are received without a notice submission, it will be failed and your notice will not be processed.

When submitting your notice request to <u>submit.egazette@gpw.gov.za</u>, please ensure that a purchase order (GPW Account customer) or proof of payment (non-GPW Account customer) is included with your notice submission. All documentation relating to the notice submission must be in a single email.

A reminder that documents must be attached separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment/purchase order – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment).

REMINDER OF THE GPW BUSINESS RULES

- □ Single notice, single email with proof of payment or purchase order.
- All documents must be attached separately in your email to GPW.
- □ 1 notice = 1 form, i.e. each notice must be on a separate form
- Please submit your notice **ONLY ONCE.**
- Requests for information, quotations and inquiries must be sent to the Contact Centre **ONLY**.
- The notice information that you send us on the form is what we publish. Please do not put any instructions in the email body.

CALL FOR OBJECTIONS IN RESPECT OF APPOINTMENTS TO THE MPUMALANGA GAMBLING BOARD

I, Sikhumbuzo Eric Kholwane, Member of the Executive Council responsible for the administration of the Mpumalanga Gambling Act, 1995 (Act no. 05 of 1995 as amended), hereby give notice of my intention to appoint the persons listed below to serve as members to the Mpumalanga Gambling Board with effect from **18 April 2016**.

In accordance with section 4(1) of the Act, the following appointments are proposed:

Sec 4(1)(c) - One member who is qualified as a chartered accountant in the Republic and has for a cumulative period of at least five years after having so qualified, practiced as a chartered accountant - **Mr. Johannes Christiaan Cronje (ID. No. 6412085029081);** and

Sec 4(1) (g) - Not more than 4 (four) members with due regard to regional interests of the Province – **Mr. Musi Skosana (ID No. 6808135402089)**

In accordance with section 6(3)(b) of the Act, any person who desires to object to the appointment of any of the aforementioned person(s) to the Board, may, not later than 14 days before the date on which the appointment of the members of the Board is intended to be made, lodge with the MEC responsible for gambling regulation in the Province; in writing an objection stating the ground or grounds which, according to such a person disqualifies the person to be appointed, from being appointed as a member to the Board.
