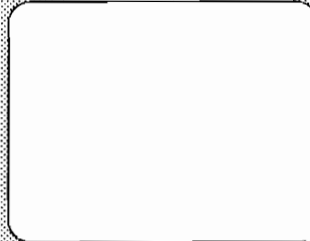

OFFICE OF THE PREMIER

It is hereby notified that the Premier has assented to the following Act which is hereby published for general information.

No. 1 of 2009: Northern Cape Special Adjustment Appropriation Act, 2009

ACT

To provide for the appropriation of an additional funding for the requirements of the Provincial Legislature in respect of the 2008/09 financial year, and to provide for matters incidental thereof.

BE IT ENACTED by the Northern Cape Provincial Legislature, as follows:-

Appropriation of additional funding for requirements of the Provincial Legislature

1. (1) Subject to the Public Finance Management Act, 1999 (Act No. 1 of 1999), as amended by Public Finance Management Amendment Act, 1999 (Act No. 29 of 1999), an amount of R10.780 million is hereby appropriated out of the Northern Cape Revenue Fund for the requirements of the Provincial Legislature in respect of the 2008/2009 financial year, as set out in the Schedule.

(2) The money contemplated in subsection (1) must be allocated as follows:
 - (a) R10.080 million to address a shortfall on constituency allowances of Members of Provincial Legislature.
 - (b) R0.700 million for operational and administrative expenses as a result of replacement of three members of Provincial Legislature.

Short title

2. This Act is called the Northern Cape Special Adjustments Appropriation Act, (2008/09 financial year), 2009.

It is hereby notified that the Premier has assented to the following Act which is hereby published for general information.

No. 2 of 2009: Northern Cape Integrated Housing and Human Settlement Development Grant Adjustment Appropriation Act, 2009

ACT

To appropriate an additional amount of money for the requirements of the Department of Housing and Local Government in respect of the financial year ending 31 March 2009.

BE IT ENACTED by the Northern Cape Provincial Legislature, as follows:-

Appropriation of additional amount of money for the requirements of the Department of Housing and Local Government.

1. Subject to the provisions of section 25 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), as amended by Public Finance Management Amendment Act, 1999 (Act No. 29 of 1999), there is hereby appropriated out of the Northern Cape Revenue Fund for the requirements of the Department of Housing and Local Government an amount of R52 000 000 (Fifty two million rand), in respect of the 2008/2009 financial year to fund the ex-cross border projects.

Short title

2. This Act shall be called the Northern Cape Integrated Housing and Human Settlement Development Grant Adjustment Appropriation Act, 2009.

It is hereby notified that the Premier has assented to the following Act which is hereby published for general information.

No. 3 of 2009: Northern Cape Provincial Finance Act, 2009**ACT**

To charge the Provincial Revenue Fund with certain unauthorized expenditure and to authorize other expenditure; and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Northern Cape Province as follows:

Defraying of unauthorized expenditure from the Provincial Revenue Fund for the financial year 2003/04.

1. (1) The unauthorised expenditure of R258,586,000.00 (Two hundred and fifty eight million, five hundred and eighty six thousand) referred in Schedule 1 which:-
 - (a) the Standing Committee on Public Accounts recommended for authorization by Provincial Legislature; and
 - (b) is more fully described in the Reports of Auditor-General, is hereby authorized.
- (2) The amount referred to in subsection (1), is a direct charge against the Provincial Revenue Fund.

Defraying of unauthorized expenditure from the Provincial Revenue Fund for the financial year 2006/07.

2. (1) The unauthorised expenditure of R40,463,000.00 (forty million, four hundred and sixty three thousand) referred in Schedule 2 which:-
 - (a) the Standing Committee on Public Accounts recommended for authorization by Provincial Legislature; and
 - (b) is more fully described in the Reports of Auditor-General, is hereby authorized.
- (2) The amount referred to in subsection (1), is a direct charge against the Provincial Revenue Fund.

Actions of recovery of money to continue

3. Nothing in this Act, in any way, may be construed as affecting action to recover unauthorized expenditure.

Short Title

4. This Act is called the Northern Cape Provincial Finance Act, 2009.
