SPECIAL ALLOWANCE OF MEMBERS OF THE EXECUTIVE COUNCIL AND MEMBERS OF THE PROVINCIAL LEGISLATURE WHOSE TENURE OF OFFICE WILL BE AFFECTED BY THE GENERAL ELECTION OF 22 APRIL 2009

The President having determined the special allowance of Members of the Executive Council and Members of the Provincial Legislature, in Proclamation No. 26 of 2009 in Government Gazette No. 32153 of 21 April 2009, whose tenure of office will be affected by the general election of 22 April 2009,

I, Hazel Getrude Jenkins, in terms of **Section 6(3)(a)** of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) hereinafter referred to as "the Act", hereby determine that, an extension of one month's salary to 31 May 2009, be paid to the current office bearer who, on 21 April 2009 -

was a Member of the Executive Council or a Member of the Provincial Legislature, and who was not designated as a representative by the Electoral Commission in terms of section 105 of the Constitution of the Republic of South Africa, 1996, pursuant to the election on 22 April 2009.

The level of remuneration of the special allowance shall be determined in accordance with the salary scales applicable in respect of the office bearers referred to above as at 22 April 2009;

Provided that a once-off gratuity will not be payable to a member in terms of Proclamation No. 31597 of 12 November 2008;

Provided that, no allowance will be payable in terms of this proclamation to a person who, within one month as from 21 April 2009, is elected or appointed to any office under the State and receives or will receive remuneration for serving in that office.
