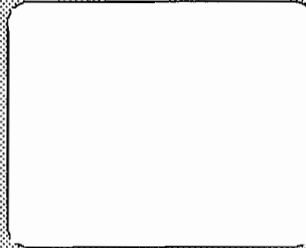

Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government: Property Rates Act, 2004 (Act No 6 of 2004), hereinafter referred to as the "Act", that the valuation roll for the financial years 01 July 2010 to 30 June 2014 is open for public inspection at the Magareng Municipal Civic Centre, Magrieta Prinsloo street, Warrenton from 5 th May 2010 to the 25th of June 2010.
