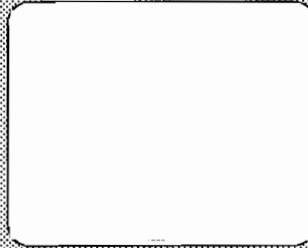

**NORTHERN CAPE LIQUOR ACT, 2008**

**PROMULGATION OF LIQUOR AMENDMENT REGULATIONS**

The Northern Cape Liquor Amendment Regulations, promulgated under Notice 18 in *Provincial Gazette* 1389 of 26 March 2010, is hereby amended as set out in the Schedule.

**SCHEDULE****Amendment of index**

1. The index is amended by the addition after the reference to "FORM 17" in the Annexure, of the following references:

**"FORM 18**

Application in terms of section 57 of the Act to supply liquor free of charge for the purpose of tasting

**FORM 19**

Application in terms of section 55 of the Act for the conversion of a licence

**FORM 20**

Non-compliance notice issued under section 43(3) of the Act".

**Amendment of regulation 3**

2. Regulation 3(3)(b) of the Regulations is amended by the substitution for the expression "regulation 41(2)(a), (b) and (c)." of the expression "subregulation (2)(c)."

**Substitution of regulation 6**

3. Regulation 6 of the Regulations is substituted by the following regulation:

**"Occasional licenses**

6. An occasional license may only allow the holder thereof to sell liquor for consumption on the licensed premises."

**Amendment of regulation 8**

4. Regulation 8 of the Regulations is amended –
  - (a) by the deletion of the words "who is the holder of a licence referred to in regulation 6" in the expression preceding paragraph (a);
  - (b) by the deletion of the word "and" at the end of paragraph (a);

- (c) by the insertion after paragraph (a) of the following paragraph:
  - “(b) furnish proof of payment of the prescribed fee; and”;
- (d) by renumbering the existing paragraph (b) to paragraph (c).

#### **Substitution of regulation 13**

5. Regulation 13 of the Regulations is substituted by the following regulation:

##### **“Procedure upon grant of application**

13. If an application is granted, a licence, substantially in the form of Form 5 contained in the Annexure, must be issued.”.

#### **Amendment of regulation 21**

6. Regulation 21 of the Regulations is amended by the insertion after the word “application” of the expression “substantially in the form of Form 17,”.

#### **Amendment of regulation 33**

7. Regulation 33 of the Regulations is amended by the insertion after the word “duplicate” of the expression “substantially in the form of Form 18,”.

#### **Amendment of regulation 39**

8. Regulation 39 of the Regulations is amended by the substitution in subregulation (1) for the number “8” of the number “7”.

#### **Amendment of regulation 45**

9. Regulation 45 of the Regulations is amended by the substitution in subregulation (1) for the number “10” of the number “9”.

#### **Amendment of regulation 59**

10. Regulation 59 of the Regulations is amended by the addition of the following proviso:

“: Provided that the Board may, in its sole discretion, relax this prescript.”.

**Amendment of regulation 62**

11. Regulation 62 of the Regulations is amended by the substitution for the caption of the following caption:

**“Report by designated police officer”.**

**Amendment of regulation 67**

12. Regulation 67 of the Regulations is amended –

- (a) by the substitution for subregulation (1) of the following subregulation:

“(1) Subject to regulation 65(2), the holder of a liquor licence (excluding an occasional liquor licence) must, no later than 31 December of each year, pay to the Board in respect of such licence, the annual fee set out in Part C of Schedule 2: Provided that:

- (a) fees received during January of the next year, shall be increased by 50%;
- (b) fees received during February of the next year, shall be increased by 100%,  
whereafter the licence shall lapse.”; and

- (b) by the addition of the following subregulation:

“(4) Notwithstanding subregulation (1), no annual fee is payable by the holder of any liquor licence for the year starting 1 January 2011 and ending 31 December 2011.”.

**Amendment of regulation 68**

13. Regulation 68 of the Regulations is amended by the addition of the following subregulation:

“(3) An application fee of R500,00 is payable for the conversion of a licence in terms of section 55 of the Act.”.

**Amendment of Schedule 1**

14. Schedule 1 of the Regulations is amended by the addition –

- (a) in Part A of the words “Occasional licence”; and
- (b) in Part B of the expression “R100,00 per day”.

**Amendment of Schedule 2**

15. Schedule 2 of the Regulations is amended by the deletion –
- (a) in the first column of the expression “**Section 16(4)** Occasional licence”; and
  - (b) in the second column of the expression “R100 per day”.

**Amendment of Annexure**

16. The Annexure to the Regulations is amended –
- (a) by the insertion in Form 3 of the word “local” before the word “municipality”;
  - (b) by the substitution for Forms 4 and 5 of the following Forms;
