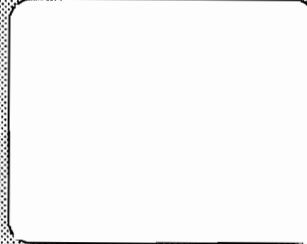

### NOTICE 16 OF 2011

By-law No. 2, 2011

WATER SERVICES AMENDMENT BY-LAW, 2011

#### AMENDMENT BY-LAW

To amend the Water Services By-Law, 7 of 2008 for the District Management Area of the John Taolo Gaetsewe District Municipality.

BE IT ENACTED by the John Taolo Gaetsewe District Municipality, as follows:-

#### Applicability

1. Only Section 81(2) of the Water Services By-Law, 7 of 2008 shall be applicable to farms.

#### Short title

2. This By-law shall be called the Water Services Amendment By-law, 2011.

**NOTICE 17 OF 2011**

**By-law No. 1, 2011 KEEPING OF ANIMALS, POULTRY AND BEES CONTROL  
AMENDMENT BY-LAW, 2011**

**AMENDMENT BY-LAW**

**To amend By-law 4 of 2008 for control of the keeping of animals, poultry and bees in the District Management Area of the John Taolo Gaetsewe District Municipality; and for matters connected therewith.**

**BE IT ENACTED** by the John Taolo Gaetsewe District Municipality, as follows:-

**Applicability**

1. The provisions of sections 2, 3, 4, 5, 6, 13, 14, 15, 16, 17, 18, 19, 20 and 21 of the Keeping of Animals, Poultry and Bees Control By-Law, 4 of 2008 shall not apply to premises which are zoned for agricultural purposes: provided that a person keeping animals, poultry and bees on premises zoned for agricultural purposes, shall not be exempted from compliance with the other provisions of this by-law.

**Short title**

2. This By-law shall be called the Keeping of Animals, Poultry and Bees Control Amendment By-law, 2010.

**SOL PLAATJE MUNICIPALITY**

**PUBLIC NOTICE CALLING FOR INSPECTION OF VALUATION ROLL AND LODGING OF OBJECTIONS**

Notice is hereby given in terms of Section 49 (1)(a)(i) of the Local Government: Municipal Property Rates Act, 2004 (Act No. 6 of 2004), hereinafter referred to as the "Act", that the valuation roll for the financial years 01 July 2011 to 30 June 2015 is open for public inspection at the Sol Plaatje Municipality Civic Centre, Customer Care Desk, from the 25<sup>th</sup> of March to the 29<sup>th</sup> April 2011.

An invitation is hereby made in terms of Section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires should lodge an objection with the municipal manager in respect of any matter reflected in, or omitted from, the valuation roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such. The form for lodging of a objection is obtainable at the Sol Plaatje Municipality Civic Centre, ground floor at the Customer Service Desk (new entrance) and at the old entrance of the building, Kimberley.
