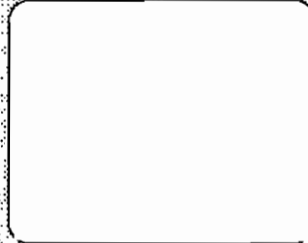

SOUTH AFRICAN SCHOOLS ACT, 84 OF 1996

By virtue of the powers vested in me in terms of Section 12A (1) of the South African Schools Act, No. 84 of 1996, as amended, I Grizelda Cjiekella, in my capacity as the Member of the Executive Council responsible for Education in the Northern Cape Province, hereby merge the following public schools in the Frances Baard District:

- Zingisa No 1, and
- Zingisa No 2.

The merger follows extensive consultation with all stakeholders in terms of Section 12A of the South African Schools Act, No. 84 of 1996, as amended.

The merger will be with effect from 31 July 2011 and the new merged school shall be Zingisa Intermediate School offering tuition from Grade R – 9.
