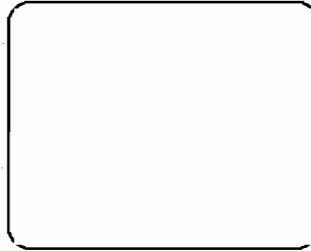

### RURAL AREA OF PELLA

### CLOSURE OF A PORTION OF A STREET

Acting under section 49A(1) of the Rural Areas Act (House of Representatives), 1987 (Act 9 of 1987) and the powers vested in me I, Alfred William Pegram in my capacity as Assistant Director: Land Administration in the Department of Co-operative Governance, Human Settlements and Traditional Affairs, Northern Cape, and as such duly authorised thereto in terms of Special Power of Attorney No. PA701/2006 conferred by the Member of the Executive Council entrusted with Co-operative Governance, Human Settlements and Traditional Affairs, being the competent authority in the legal jurisdiction of the Government of the Province Northern Cape in terms of Proclamation No.R154 dated 13 October 1994, in execution of the powers conferred in terms of the Rural Areas Act (House of Representatives), 1987 (Act No. 9 of 1987), and on behalf of Khâi-Ma Municipality, hereby close a portion of a street in Pella as set out in the Schedule.

### SCHEDULE

1. Closure and subdivision of a portion of a street to form Erf 1084 Pella and to consolidate the closed portion with Erf 274 Pella to form Erf 1085 Pella.
2. The above closure is without conditions.
