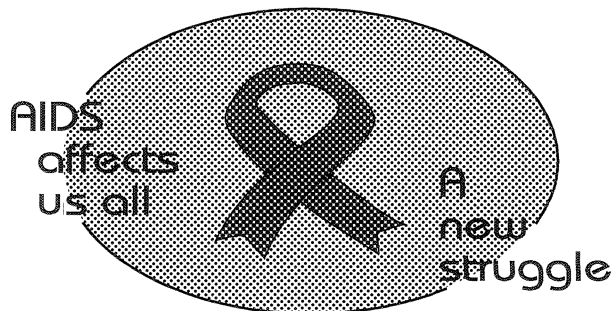

02 OF 2007 IN BA-GA PHETLHU TRADITIONAL COMMUNITY**

1. Section 6 of the Northern Cape Traditional Leadership, Governance and Houses of Traditional Leaders Act 2007 (Act No. 2 of 2007) ("the Act"), establishes Traditional Councils for every Traditional Community recognized in terms of the Act in the Northern Cape Province, and pursuant thereto I, **Sylvia Elizabeth Lucas**, in my capacity as the Premier of the Northern Cape Province -
  - a) Hereby in terms of section 6(3) of the **Northern Cape Traditional Leadership, Governance and Houses of Traditional Leaders Act** publish the names of all candidates who were elected in terms of section 6(2)(c)(ii) of the Act, by way of ballot, on the 23<sup>rd</sup> February 2013 and those who were selected by their Senior Traditional Leaders in terms of section 6(2)(c)(i) of the Act as they appear in the *schedule* for the Ba ga Phetlhu Traditional Community, Camden Village.
