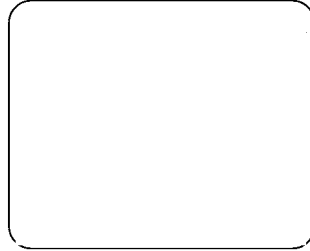

### PROCLAMATION Northern Cape Province

#### SIYANDA DISTRICT MUNICIPALITY: CLOSING AND PROCLAMATION OF ROADS

Under sections 3, 4 and 24 OF THE ROADS Ordinance (Ordinance 19 of 1976), and section 7 of the Advertising on Roads and Ribbon Development Act, 1940 (Act 21 of 1940), I hereby-

1. declare that a road, situated in Siyanda District Municipality, as indicated by means of a unbroken blue line marked A-B on plan **RL(S) 1/2010** and as described in **Schedule 1**, which is filed in the offices of the Siyanda District Municipality, UPINGTON, shall be closed.

**Schedule 1:**

Minor Road 82, from its junction with Main Road 886 on the property remainder 122 Windhoek, across the properties remainder 122 Windhoek, remainder 129 Koppieskraalpan en 1/123, up to its junction with Minor Road 83 on property 1/123. A distance of approximately 11.2km.

2. declare that a road, situated in Siyanda District Municipality, as indicated by means of a unbroken blue line marked B-C on plan **RL(S) 1/2010** and as described in **Schedule 2**, which is filed in the offices of the Siyanda District Municipality, UPINGTON, shall be closed.

9. declare that a road, situated in Siyanda District Municipality, as indicated by means of a unbroken blue line marked **A-B** on plan **RL(S) 8/2010** and as described in **Schedule 1**, which is filed in the offices of the Siyanda District Municipality, UPINGTON, shall be closed.

Minor Road 35, from the junction with Minor Road 15(A) on property RE/275, across properties RE/275, RE/305 and RE/304 Klipheuwels, up to its end on property remainder 304 Klipheuwels. A distance of approximately 13.0km.

10. declare that a road, situated in Siyanda District Municipality, as indicated by means of a unbroken blue line marked **C-D** on plan **RL(S) 9/2010** and as described in **Schedule 1**, which is filed in the offices of the Siyanda District Municipality, UPINGTON, shall be closed.

A distance of approximately 67.2 km

23. declare that a road, situated in Siyanda District Municipality, as indicated by a broken green line marked **B-F** on plan **RL(S) 22/2010** and as described in **Schedule 2**, which is filed in the offices of the Siyanda District Municipality, UPINGTON, shall be proclaimed as a Divisional Road.

**Schedule 2**

Proposed Divisional Road from the junction with Minor Road 86 on the common boundary of the properties 37/585, 38/585, 61/585 and 62/585, across properties 61/585, 62/585, 69/585, 72/585, 71/585, 113/585, 114/585, 125/585 and 108/585, up to the junction with Trunk Road 87/2 on the common boundary of the properties 108/585 and RE/585. A distance of approximately 28.5 km

24. declare that a road, situated in Siyanda District Municipality, as indicated by means of a broken green line marked **D-F** on plan **RL(S) 22/2010** and as described in **Schedule 3**, which is filed in the offices of the Siyanda District Municipality, UPINGTON, shall be proclaimed as a Divisional Road.

**Schedule 3**

26. declare that a road, situated in Siyanda District Municipality, as indicated by means of a broken green line marked **H-K** on plan **RL(S) 22/2010** and as described in **Schedule 5**, which is filed in the offices of the Siyanda District Municipality, UPINGTON, shall be proclaimed as a Divisional Road.

**Schedule 5**

Proposed Divisional Road from the junction with a road on the property 1/108, across properties 1/108 and 104/585, across properties Trunk Road 87 Section 2 on property 104/585. A distance of approximately 3.0 km.

27. declare that a road, situated in Siyanda District Municipality, as indicated by means of a broken green line marked **G-N** on plan **RL(S) 22/2010** and as described in **Schedule 6**, which is filed in the offices of the Siyanda District Municipality, UPINGTON, shall be proclaimed as a Divisional Road.
