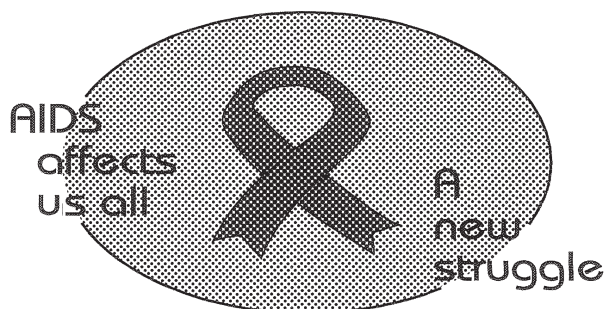

## PROCESSING and Business Rules for notices

Government Printing Works will become the custodian of the Northern Cape Gazettes from **Monday, 04 January 2016**.

GPW will start accepting notices from Northern Cape (NC) customers with the following conditions:

- Any submissions received from the NCPL (Northern Cape Provincial Legislature) from the 01 January 2016 will be rejected.
- Any submissions received from NC customers where the proof of payment is made to NCPL will also be rejected.
- Over and above these 2 points, the GPW Business rules and Submissions deadlines will apply.

Please refer below for business and processing rules, submission deadlines and other important information related to publishing of notices in the Northern Cape Gazettes.

### GPW BUSINESS RULES

- ☐ Single notice, single email – with proof of payment or purchase order.
- ☐ All documents must be attached separately in your email to GPW.
- ☐ 1 notice = 1 form, i.e. each notice must be on a separate form
- ☐ Please submit your notice **ONLY ONCE**.
- ☐ Requests for information, quotations and inquiries must be sent to the Contact Centre **ONLY**.
- ☐ The notice information that you send us on the form is what we publish. Please do not put any instructions in the email body.

### CANCELLATIONS

Don't forget!

Cancellation of notice submissions are accepted by GPW according to the deadlines stated in the table above. Non-compliance to these deadlines will result in your request being failed. **Please pay special attention to the different deadlines for each gazette.**

Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.

Requests for cancellation must be sent by the original sender of the notice and must be accompanied by the relevant **notice reference number (N-)** in the email body.

EXTENTION OF THE DECLARATION OF THE NORTHERN CAPE PROVINCIAL STATE OF DROUGHT DISASTER**

I, Sylvia Lucas, in my capacity as Premier of the Province of Northern Cape, under powers vested in me by Section 41(5)(c) of the Disaster Management Act, 2002 (Act No. 57 of 2002), hereby, as a result of the continuing protracted drought and the subsequent damage and possibility of loss of life, extend the declaration of a Provincial State of Drought Disaster in-

- (a) Frances Baard District Municipality
- (b) ZF Mqawu District Municipality
- (c) Namakwa District Municipality
- (d) Pixley Ka Seme District Municipality
- (e) John Taolo Gaetsewe District Municipality

For the period of one (1) month from the 18 March 2016 until 17 April 2016
