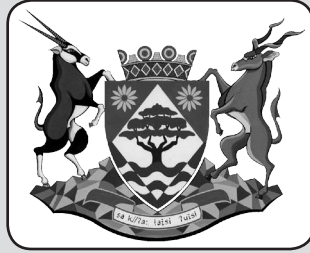

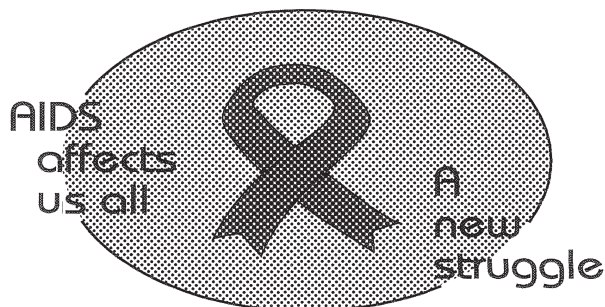

In accordance with section 12 (6) (a) of the Division of Revenue Act 3 of 2016 No 39995 I MacCollen Ntsikelelo Jack, MPL in my capacity as the Member of the Executive Council for Finance, Economic Development and Tourism hereby publish the list of planned expenditure from the Human Settlements Development Grant for Level 1 and 2 Accredited Municipalities as well as the transfers in terms of the Level 1 and 2 accreditation support over the Medium Term Expenditure Framework.

The Act stipulates that the *"The receiving officer of the Human Settlements Development Grant must in consultation with the transferring officer, publish in the Gazette within 14 days after the act takes effect, the planned expenditure from the Human Settlements Development Grant, for the 2016/17 financial year the 2017/18 financial year and the 2018/19 financial year per municipality with level one or level two accreditation"*
