PREMIER'S NOTICE 1 OF 2019*by the**Premier of the Northern Cape Province***DETERMINATION OF THE UPPER LIMIT OF THE SALARIES AND ALLOWANCES OF THE MEMBERS OF THE EXECUTIVE COUNCIL AND MEMBERS OF THE PROVINCIAL LEGISLATURE**

1. The President having determined the upper limit of the salaries of Members of the Executive Council and Members of the Provincial Legislature (Government Gazette No. 42107 of 13 December 2018.)

I, **Sylvia Elizabeth Lucas**, in terms of Section 6 (3) (a) of the **Remuneration of Public Office Bearers Act, 1998 (Act No. 20 OF 1998)** (hereinafter referred to as the "the Act"), hereby determine that the upper limit of salaries of the positions of office bearers mentioned in Column 3 of Schedule 1 shall be as set out in column 4 of Schedule 1 with effect from 1 April 2018, subject to provisions of Section 6 (2) to 9 of the Act, and in terms and conditions set out herein.

2. The total remuneration packages shall include the following elements:
 - 2.1 A basic salary component equal to 60% of the total package, which constitutes the pensionable salary;
 - 2.2 An amount of 120 000 per annum, which is an amount to which section 8 (1) (d) of the income Tax Act, 1962, applies. This amount is included in the basic salary component;

- 2.3 An employer's pension benefit contribution equal to 22.5% of pensionable salary; and
- 2.4 A flexible portion for the remaining amount of the total remuneration.
