GENERAL NOTICE 28 OF 2021

NOTIFICATION: ENVIRONMENTAL AUTHORISATION APPLICATION PROCESS.

In accordance with the requirements of Chapter 6 of the Environmental Impact Assessment (EIA) Regulations (Government Notice R982 as amended, promulgated under the National Environmental Management Act 107 of 1998-NEMA), notice is herewith given of an application/s which will be subjected to a public participation process.

Tosaco Energy (Pty) Ltd (hereafter referred to as the applicant - Tosaco) has appointed Environmental Impact Management Services (Pty) Ltd (EIMS) as the Environmental Assessment Practitioner (EAP) to assist with undertaking the required authorisation processes (including the statutory public participation), and to compile and submit the required documentation.

Application/s: Environmental Authorisation (EA) in accordance with the NEMA Listed activity/ies:

- NEMA GNR 984: Activity 18:

Any activity including the operation of that activity which requires an exploration right as contemplated in section 79 of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002), including:

- (a) associated infrastructure, structures and earthworks; or
- (b) the primary processing of a petroleum resource including winning, extraction, classifying, concentrating or water removal;

but excluding the secondary processing of a petroleum resource, including the beneficiation or refining of gas, oil or petroleum products in which case activity 5 in this Notice applies.

Additional listed activities and/or water uses may be identified during the process.

Location: The proposed project area is defined as offshore exploration Block 1, located offshore between Alexander Bay, extending south along the western coastline to approximately Hondeklip Bay and approximately 250 km offshore of the coast of the Northern Cape. Block 1 outline corner coordinate points are as follows:

Activity: Tosaco has applied for an Exploration Right for offshore oil and gas in Block 1, located along the West Coast of South Africa. The exploration works programme includes the following:

- Year 1 Activities:
 - Review of all available technical data (Geographical Information System (GIS) data; Geophysical data, geological data, borehole data and log data; Third party technical reports);
 - Reprocessing of existing geological/geophysical data.
 - Preliminary estimation of contingent resources.
 - Prepare conceptual design and program of future geophysical and geological exploration and appraisal.
- Year 2 Activities: Planning and preparation of possible seismic survey.
- Year 3 Activities:
 - Possible 2D and/ or 3D seismic survey.
 - Processing and interpretation of seismic data.
 - Evaluation and estimation of contingent resources based on new data.

EIMS will be following the procedures defined in the EIA Regulations for undertaking a Scoping and Environmental Impact Assessment (EIA) process. In accordance with Chapter 6 of the EIA Regulations, a public participation process will be undertaken. You are hereby invited to register and comment on the proposed project and application/s. OMGEWING KENNISGEWING: VOORGESTELDE KOKFONTEIN REGTE AANSOEK vir OMGEWINGSMAGTIGING

Kennis geskied hiermee in terme Hoofstuk 6 van die Regulasies oor Omgewingsimpakbelasting, 2014, uitgevaardig kragtens die Nasionale Wet op Omgewingsbestuur (Wet 107 van 1998) (NEMA, soos gewysig) vir aansoek om Omgewingsmagtiging (EA).

Tosaco Energy (Pty) Ltd (Hierna verwys as Tosaco) het Environmental Impact Management Services (Pty) Ltd (EIMS) as die Omgewingsassesseringpraktisy (EAP) aangestel om te assisteer met die vereiste magtigingsprosesse (insluitend die statutêre publieke deelname), en om die nodige dokumentasie te verskaf.

Aansoek: Omgewingsmagtiging (EA) in ooreenstemming met die Wet op Nasionale Omgewingsbestuur (NEMA), gelyste aktiwiteite:

- NEMA GNR 984: Aktiwiteit 18:

Enige aktiwiteit, insluitend die bedryf van daardie aktiwiteit wat 'n eksplorasiereg vereis soos beoog in artikel 79 van die Wet op die Ontwikkeling van Minerale en Petroleumhulpbronne, 2002 (Wet No. 28 van 2002), insluitend:

- (a) gepaardgaande infrastruktuur, strukture en grondwerke; of
- (b) die primêre verwerking van 'n petroleumbron, insluitend ontginning, klassifiseer, konsertere of verwydering van water;

maar uitsluitend die sekondêre verwerking van 'n petroleumbron, insluitend die veredeling of raffinering van gas, olie of petroleumprodukte, in welke geval aktiwiteit 5 in hierdie kennisgewing van toepassing is.

Addisionele gelyste aktiwiteite kan gedurende die aansoekproses geïdentifiseer word.

Liggings: Die voorgestelde projek area is gedefinieer as 'Seewaardse Eksplorasie Blok 1', seewaarts geleë tussen Alexander Baai, teen die Weskus langs tot ongeveer by Hondeklip Baai. Die area strek vanaf die kus tot ongeveer 250 km seewaarts. Blok 1 se hoek koördinate is as volg:

Aktiwiteit: Tosaco het die aansoek gedaan vir 'n eksplorasie vir olie en gas in Blok 1, geleë langs die Weskus van Suid Afrika. Die verkenningprogram sluit die volgende in:

- Jaar 1 Aktiwiteite
 - Hersiening van alle bekembare tegniese data (Geografiese inligtingstelsels (GIS) informasie; Geofisiese, geologiese, boorgat en log informasie; Derde party tegniese verslae)
 - Herverwerking van bestaande geologiese/geofisiese informasie.
 - Vorlopige bepaling van hulpbronne.
 - Berei konseptuele ontwerp en program vir vir toekomstige geofisiese en geologiese verkenning en assessering.
- Jaar 2 Aktiwiteite: Beplanning en voorbereiding van moontlike seismiese opnames.
- Jaar 3 Aktiwiteite
 - Moontlike 2D en/ of 3D seismiese opname.
 - Verwerking en interpretasie van seismiese informasie.
 - Evaluering en beraming van hulpbronne gebaseer op nuwe data.

EIMS sal die procedures soos gedefinieer in die Omgewingsimpakstudie (EIA) Regulasies (GRN982 van 2014, soos gewysig) vir die uitvoering van 'n omvangsbelasting en omgewingsimpakstudie (EIA) volg. In ooreenstemming met Hoofstuk 6 van die EIA-Regulasies, sal 'n proses van openbare deelname gedoen word. U word hiermee uitgenooi om te registréer en kommentaar te lewer op die voorgestelde projek en aansoek/ e. U moet asseblief u naam, kontakbesonderhede, die rede vir u belangstelling, skriftelik of telefonies, binne 30 dae na hierdie kennisgewing, aan EIMS voorstel om te verseker dat u geïdentifiseer en geregistreer is as 'n Belangstellende en Geaffekteerde Party (I&AP). Let daarop dat slegs geregistreerde I&Ps in kennis gestel sal word van toekomstige projek inligting en geleenthede vir deelname.
