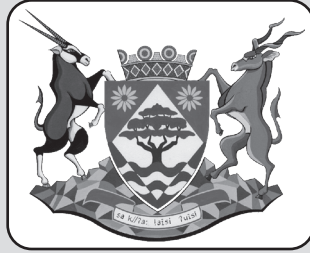

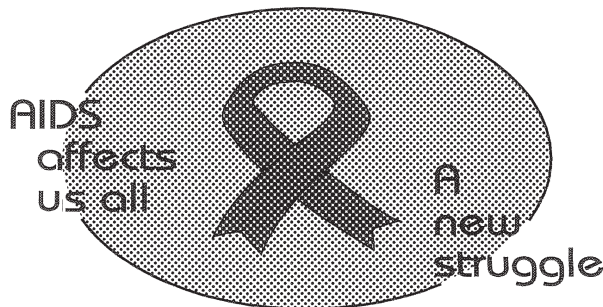

I Bentley Gavin Vass, in my capacity as the Member of the Executive Council of the Northern Cape responsible for Co-operative Governance, Human Settlements & Traditional Affairs, hereby amend Section 12 Notice published in the Northern Cape Provincial Gazette No. 27 of 2000 as amended by Notice 25 of 2001 in respect of the **Type** of municipality mentioned in schedule (A) hereunder from Plenary Executive Council to a **Municipality with a Mayoral Executive System combined with a ward participatory system**.

The local municipalities may designate the following councillors as full-time:

- (i) Mayor
- (ii) Speaker
