The term "licence" used in paragraph 1 of this Notice is deemed to include partnerships of two or more bookmakers and equates to the term "bookmaking right" which is widely used in the betting industry. In other words, each licence is divisible among two or more partners, but no licence may be split between partners to create separate betting outlets.

This determination is effective from **1 May 2006** and all previous determinations made by the Minister in terms of section 22(10) of the Regulation of Racing and Betting Ordinance, 1957 (Ordinance No. 28 of 1957) are hereby rescinded with effect from 30 April 2006.
