The building lines to Spinks Road and Bouverie Road may be relaxed from 7,5m to 4,5m.

**4. Environmental Authorisation**

The conditions of approval in terms of section 28 of the National Environmental Management Act, No 107 of 1998, as stated in paragraphs 8.1 to 8.25 of the KZN Department of Agriculture and Environmental Affairs' letter of approval reference EIA/5644 and dated 02 November 2005 shall be adhered to.

**5. Environmental Management Plan**

The environmental management plan prepared by Buk'Indalo Consulting cc and as approved by the KZN Department of Agriculture and Environmental Affairs, for the construction and operational phases of the site's development is to be adhered to.

**6. Consolidation**

Prior to the development of the site, the consolidation of erven 968, 969 and 971 Shelly Beach into erf 1111 Shelly Beach, as per approved SG Diagram No. 1075/1979, shall be registered.

**7. Geotechnical report**

The development of the site is to take cognisance of the recommendations of the foundation investigation report prepared by Drennan Maud and Partners, dated January 2005 and referenced 16404.

**8. Road Improvements**

The improvements to the geometry of the Spink Road/Marine Drive intersection, as recommended in the Traffic Impact Assessment report prepared by De Lew Cather Emtatani, dated March 2005, are to be implemented at the cost of the developers of the site.

**9. KZN Department of Transport Requirements**

The following are the requirements of the KZN Department of Transport:

9.1 In terms of Section 13 of the KwaZulu-Natal Provincial Roads Act No. 4 of 2001, no buildings or any structures whatsoever, other than a fence, hedge or a wall which does not rise higher than 2,1 metres above the surface of the land on which it stands, shall be erected on the land within a distance of 7,5 metres measured from the road reserve boundary of Main Road 395 (Marine Drive).

9.2 The road reserve boundary of Main Road 395 shall be determined in consultation with KZN Department of Transport's Cost Centre Manager, Port Shepstone.

9.3 The applicant's attention is drawn to the relevant stormwater clause contained in the KwaZulu-Natal Provincial Roads Act No. 4 of 2001, wherein it is advised that the disposal of stormwater emanating from the road reserve through the layout, or any stormwater emanating from the layout through the road reserve, shall be undertaken in consultation with and to the satisfaction of KZN Department of Transport's Cost Centre Manager, Port Shepstone during the development of the property concerned.

9.4 In terms of Section 10 of the KwaZulu-Natal Provincial Road Act No. 4 of 2001,

no direct access to Main Road 395 (Marine Drive) will be permitted. Access is to be obtained from Spink Road and shall be positioned a minimum of 60 metres from the intersection of Main Road and Spink Road.

9.5 The intersection access point to Main Road 395 and Spink Road shall be designed by a registered professional engineer, in consultation with the Head: Transport, Department of Transport KwaZulu-Natal to a type "B2" blacktop standard symmetrical about the centre line of Main Road 395 with double right turn refuge lanes and the design thereof (inclusive of a pavement design) submitted to the Design Engineer of the Road Design and Control Component, Department of Transport KwaZulu-Natal, for approval.

9.6 The intersection access point to Main Road 395 and Spink Road shall be upgraded in consultation with and to the satisfaction of KwaZulu-Natal Department of Transport's Cost Centre Manager, Port Shepstone in accordance with the approved design.

9.7 Adequate parking facilities must be provided within the property itself.

9.8 All costs incurred as a result of these requirements shall be borne entirely by the developer.

9.9 Upon compliance with the above conditions the applicant shall request the Regional Director to inspect and submit a letter of compliance of the above conditions to the Head: KwaZulu-Natal Department of Transport.

### SECTION C

#### REASON FOR JUDGEMENT

- The proposed development complies with the general principles of the Development Facilitation Act in the following respects namely:
  - that it is a development which will provide for improved land usage,
  - it will prevent illegal occupation of land in question,
  - it will provide residential accommodation which is needed,
  - it will provide employment opportunities and
  - it will be sustainable development.
- The Proposed development is within the Hibiscus town planning scheme and is not in conflict with any integrated development plan or spatial development frame work and has the support of the Ugu District Municipality and Hibiscus Coast Municipality.
- The development has the support of the Department of Agriculture and Environmental Affairs which has issued a Record of Decision setting out various conditions which have been accepted by the applicant. In

addition there will be an environmental management plan which will monitor the development and ensure protection of sensitive areas.

- KwaZulu-Natal Department of Transport has also indicated support for the application subject to certain conditions which the applicant has accepted.
- There are no objections to the application.
