Ngokwesigaba 105(2) soMthetho weziNhlelo zoMasipala woHulumeni baseKhaya, 2000 (uMthetho No. 32 ka 2000), sifundwa nezigaba 155(6) kanye no 155(7) zoMthethosisekelo weRiphabhuliki yaseNingizimu-Afrika, 1996, ulwazi oludingeka kulolu Hlelo, kumele luthunyelwe yibo bonke oMasipala abasesiFundazweni saKwaZulu-Natali kwiLungu loMkhandlu oPhethe esiFundazweni saKwaZulu-Natali elibhekele ohulumeni basekhaya ("iLungu loMkhandlu oPhethe"), maqondana nomphathi womasipala ngamunye, isekela lomphathi kamasipala ngalinye kanye nabo bonke abaphathi abanesibopho sokubika kumphathi kamasipala (bonke ababizwa ngokuthi "yiziphathimandla").

- (d) Nemininingwane yanoma yikuphi okunye okupathelene nalolu daba kanye nanoma yiziphi izinyathelo noma izinyathelo zokulungisa uMkhandlu ozithathile ngenxa yalokho;

(2) Ukuxoshwa:

- (a) Imininingwane egcwele ngemiphumela yokuLalelwa kokuQondiswa kweziGwegwe noma ukuLalelwa okupathelene nokuxoshwa emsebenzini kwezipathimandla, kubandakanya nanoma yiziphi izihlongozo ezenziwe noma ukuvumelana okwenzekile okupathelene nokuxoshwa emsebenzini; kanye
- (b) Nemininingwane egcwele yanoma yikuphi okunye okupathelene nodaba olubekiwe ngenhla nanganoma yiziphi izinyathelo eziqhubekayo noma izinyathelo zokulungisa uMkhandlu ozithathile ngenxa yalokho;

(3) Ukwesula emsebenzini:

- (a) Usuku lokwesula emsebenzini;
- (b) Izizathu zokwesula emsebenzini; kanye
- (c) Nemininingwane egcwele yanoma yiziphi izihlongozo zokukhokhwa kwezimali ezenziwe noma izivumelwano ezithathiwe eziphathelene nokwesula emsebenzini; kanye

(4) Nokufa:

- (a) Usuku lokufa.

3. Ulwazi oluhlongozwe kwimishwana 1 kanye no-2 kumele lungeniswe zingakapheli izinsuku eziyishumi nane zokushicilelwka kwaesi saziso, maqondana nezipathimandla ezaqokwa, ezamiswa, ezaxoshwa, ezasula emsebenzini noma ezashona ngonyaka ka 2004.

WITHDRAWAL AND REPLACEMENT OF NOTICE NO. 391 OF 2005, DATED 10 MARCH 2005 AND NOTICE NO. 88 OF 2006, DATED 26 JANUARY 2006, PUBLISHED IN TERMS OF SECTION 105(2) OF THE LOCAL GOVERNMENT: MUNICIPAL SYSTEMS ACT, 2000

I, Michael Mabuyakhulu, Member of the KwaZulu-Natal Executive Council responsible for Local Government, Housing and Traditional Affairs, and in terms of powers vested in me by section 105(2) of the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), hereby withdraw Provincial Notice No. 391 of 2005 dated 10 March 2005, as well as Provincial Notice No. 88 of 2006 dated 26 January 2006, and replace same with the Notice contained in the Schedule.

SCHEDULE

In terms of section 105(2) of the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), read with section 155(6) and 155(7) of the Constitution of the Republic of South Africa, 1996, the information required in this Schedule, must be submitted by all Municipalities within the Province of KwaZulu-Natal, to the Member of the Executive Council for the Province of KwaZulu-Natal responsible for local government ("the MEC"), in respect of each municipal manager, deputy municipal manager and all managers directly accountable to the municipal manager (collectively referred to as "the officials").

1. The following information must be submitted bi-annually, on 30 June and 30 December of each year, in respect of the officials:

- (1) Full description of position;
- (2) Name of the Incumbent;
- (3) Highest academic qualification;
- (4) Copy of employment contract;
- (5) Copy of performance agreement;

(6) Details of remuneration including—

- (a) Basic salary;
- (b) Any allowances and service benefits; and
- (c) The total cost to employer of the official's remuneration package.

2. The following information must be submitted in respect of the officials, within fourteen days of any event contemplated hereunder occurring:

(1) Suspensions:

- (a) Full details giving rise to the decision by the Executive Committee or Council to suspend the officials;
- (b) Full details of any charges or subsequent charges formulated against the officials during the Disciplinary Enquiry process;
- (c) Full details of the outcome of the Disciplinary Hearing process in the case of the retention of the officials' services; and
- (d) Full details on any other matters incidental to this issue and any further actions or corrective measures the Council may have taken as a consequence;

(2) Dismissals:

- (a) Full details of the outcome of the Disciplinary Hearing or Hearings pertaining to a removal from Office of the officials, including any settlement proposals or agreements that may have been reached pertaining to termination of service; and
- (b) Full details of any other matters incidental to the abovementioned issue and any further actions or corrective measures the Council may have taken as a consequence;

(3) Resignations:

- (a) Date of resignation;
- (b) Reasons for the resignation; and
- (c) Full details of any settlement proposals or agreements that may have been reached pertaining to the resignation; and

(4) Death:

- (a) Date of death.

3. The information contemplated in clauses 1 and 2 must be submitted retrospectively for the period 1 January 2004 to the present, within fourteen days of the date of publication of this notice, in respect of the officials who—

- (a) were appointed;
- (b) were suspended;
- (c) were dismissed;
- (d) resigned; or
- (e) passed away.

4. The following information must be submitted for approval by the MEC, before any financial settlement or agreement contemplated in clauses 2(2)(a) or 2(3)(c) is concluded with the officials:

- (a) a copy of the Council resolution authorising the financial settlement or agreement;
- (b) the full details of the content of the financial settlement or agreement;
- (c) full details of the legislative provisions in terms of which the financial settlement or agreement was concluded; and
- (d) the provision on the budget of the municipality of that financial year, for such financial settlement or agreement.

BYLAE

Ingevolge artikel 105(2) van die Wet op Plaaslike Regering: Munisipale Strukture, 2000 (Wet No. 32 van 2000), saamgelees met artikels 155(6) en 155(7) van die Grondwet van die Republiek van Suid-Afrika, moet die inligting in hierdie bylae vereis, deur alle munisipaliteite in die provinsie KwaZulu-Natal aan die lid van die Uitvoerende Raad vir plaaslike regering ("die LUR") voorgelê word ten opsigte van elke munisipale bestuurder, adjunk- munisipale bestuurder en alle bestuurders wat regstreeks teenoor die munisipale bestuurder verantwoordelik is (kollektief aangedui as "die amptenare").

1. Die volgende inligting moet twee keer per jaar, op 30 Junie en 30 Desember van elke jaar, ten opsigte van die amptenare voorsien word:

- (1) Volledige posbeskrywing;
- (2) Naam van posbekleer;
- (3) Hoogste akademiese kwalifikasie;
- (4) Afskrif van dienskontrak;
- (5) Afskrif van prestasie-ooreenkoms;
- (6) Besonderhede van vergoeding met inbegrip van –
 - (a) Basiese salaris;
 - (b) Enige toelaes/diensvoordele; en
 - (c) Die werkewer se totale uitgawe met betrekking tot die amptenaar se vergoedingspakket.

2. Die volgende inligting moet ten opsigte van die amptenare voorgelê word binne veertien dae nadat die gebeurtenis hieronder vermeld, plaasgevind het:

- (1) Skorsings:
 - (a) Volledige besonderhede wat aanleiding gegee het tot die besluit van die Uitvoerende Komitee of Raad om die amptenare te skors;
 - (b) Volledige besonderhede van enige aanklagte of daaropvolgende aanklagte wat tydens die dissiplinêre ondersoekproses teen die amptenare geformuleer is;
 - (c) Volledige besonderhede van die uitslag van die dissiplinêre ondersoek in die geval van die behoud van die amptenare se dienste; en
 - (d) Volledige besonderhede oor enige aangeleenthede wat met die saak verband hou en enige verdere optrede of korrektiewe maatreëls as wat die Raad as gevolg daarvan geneem het;
- (2) Ontslag:
 - (a) Volledige besonderhede van die uitslag van die dissiplinêre verhoor of verhore wat met die ontslag van die amptenare verband hou, met inbegrip van enige skikkingsvoorstelle of ooreenkomste wat met betrekking tot diensbeëindiging bereik is; en
 - (b) Volledige besonderhede oor enige aangeleenthed wat met die bovermelde saak verband hou en enige verdere optrede of korrektiewe maatreëls wat die Raad as gevolg daarvan geneem het;
- (3) Bedankings:
 - (a) Datum van bedanking;
 - (b) Rede vir die bedanking; en
 - (c) Volledige besonderhede van enige skikkingsvoorstelle of ooreenkomste wat met betrekking tot die bedanking bereik is; en
- (4) Afsterwe:
 - (a) Datum van afsterwe.

3. Die inligting vermeld in klousules 1 en 2 ten opsigte van die amptenare wat aangestel is, geskors is, ontslaan is, bedank het of te sterwe gekom het gedurende 2004, moet met terugwerkende krag voorgelê word binne veertien dae na die datum van hierdie kennisgewing.

4. Die volgende inligting moet voorgelê word vir goedkeuring deur die LUR voordat enige finansiële skikking of ooreenkoms bedoel in klousules 2(2)(a) of 2(3)(c) met die amptenare gesluit word:

- (a) 'n afskrif van die Raadsbesluit wat die finansiële skikking of ooreenkoms magtig;
- (b) die volledige besonderhede van die finansiële skikking of ooreenkoms;
- (c) volledige besonderhede van die wetgewende bepalings ingevolge waarvan die finansiële skikking of ooreenkoms gesluit is; en
- (d) die voorsiening in die munisipaliteit se begroting van daardie jaar vir sodanige skikking of ooreenkoms.
