DECLARATION OF PROVINCIAL ROADS

N terms of section 7 of the KwaZulu Natal Roads Act, 2001 (Act No. 4 of 2001), the Minister declares that as from the date of publication hereof —

- (a) the roads specified in Schedule A hereunder, shall in terms of section 7(2)(b)(iii) be closed and cease to be district roads, which the public has the right to use; and
- (b) the roads specified in Schedule B hereunder, shall in terms of section 7(2)(b)(iii) cease to be district roads, but shall in terms of section 31(1)(a) be a Public Right-of-Way 10m wide in accordance with the provisions of the said Act, which the public has the right to use; and
- (c) the roads specified in Schedule C hereunder, shall in terms of section 7(2)(b)(iii) be closed and cease to be local roads which the public has the right to use; and
- (d) the roads specified in Schedule D hereunder, shall in terms of section 7(2)(a) be district roads; and
- (e) the roads specified in Schedule E hereunder, shall in terms of section 7(2)(a) be local roads.

1. The KwaZulu-Natal Youth Commission Act, 1998 (Act No. 1 of 1998), has been repealed by the KwaZulu-Natal Youth Commission Act, 2005 (Act No. 7 of 2005), hereafter referred to as "the Act".

The Act re-establishes the KwaZulu-Natal Youth Commission and provides for the appointment of six full-time members to constitute the Commission.

- 2. Acting in terms of section 5(2) of the Act, the Premier invites the nominations of persons to be recommended for appointment as members of the KwaZulu-Natal Youth Commission. The nominations must be made within 21 days of the publication of this Notice.
- 3. To qualify for appointment, a person must -
 - (a) be a South African citizen resident in the Province;

(b) be between the ages of 14 and 35;

(c) possess the necessary qualifications, knowledge, skill or experience required to perform the functions of the Commission: Provided that at least one member of the Commission must have proven knowledge of, or experience in, financial management; and

(d) not be ineligible to remain in office in terms of paragraphs (a) to (l) of section 10(1) of the Act.

- 4. Commissioners are appointed until the date of the election of the Provincial Legislature immediately following the date of appointment at a remuneration determined by the Premier after consultation with the Member of the Executive Council of KwaZulu-Natal responsible for finance. Details of the remuneration and benefits presently payable to Commissioners can be ascertained on enquiry from the Office of the Premier at the address given in this Notice.
- 5. The principal functions of the KwaZulu-Natal Youth Commission relate to the facilitation of the implementation of the National Youth Policy, the facilitation, monitoring and evaluation of the protection, promotion and fulfillment of the rights of the youth by the government, the promotion of the development of the youth, the promotion of a uniform approach by provincial organs of state in respect of youth matters, uniting the youth, the promotion of a spirit of patriotism among the youth, the education of the youth on their rights and to assist them in accessing their rights.

(b) a certified copy of nominee's identity document; and

- (ii) could reasonably be expected to compromise the Commission in the performance of its functions; and

(b) containing relevant information about any conviction –

(i) for a Schedule 1 offence in terms of the Criminal Procedure Act, 1977 (Act No. 51 of 1977); and

(ii) for an offence of which dishonesty is an element.
