THE KWAZULU-NATAL ADJUSTMENTS APPROPRIATION ACT AMENDMENT ACT, 2006

(Act No. 1 of 2006)

Assented to on 2006-04-06

ACT

To amend the KwaZulu-Natal Adjustments Appropriation 2005/06 Act and Schedule thereof which appropriated an adjusted amount of money for the requirements of the Province in respect of the financial year ending 31 March 2006, and to provide for matters incidental thereto.

BE IT ENACTED by the Provincial Parliament of the Province of KwaZulu-Natal, as follows: —

Appropriation of adjusted amounts of money for requirements of the Province

1. Subject to the provisions of the Public Finance Management Act, Act No. 1 of 1999 (as amended by Act No. 29 of 1999), there are hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province, in respect of the financial year ending 31 March 2006, as a charge to the Provincial Revenue Account, the adjusted amounts of money shown in the amended schedule.

Amendment of the Schedule

2. The Schedule to this Act hereby reflects the amendments to the Schedule of the KwaZulu-Natal Adjustments Appropriation Act, 2005 in respect of Vote 6 – Programme 5, Vote 8 – Programme 3; and Vote 13 – Programme 2.

Short title

3. This Act shall be called the KwaZulu-Natal Adjustments Appropriation Act Amendment Act, 2006.
