3. Any person who feels aggrieved by any decision or order of the Municipality in respect of any matter referred to in paragraph 2 above may, pursuant to Section 67 *ter* of the

Ordinance, give notice to the Municipal Manager within 28 days of being notified of such decision or order, of his intention of appeal to the Town Planning Appeals Board, setting forth in such notice his grounds of appeal, and shall also lodge with the Secretary of the Appeals Board within 21 days of his giving such notice a memorandum setting out his grounds of appeal, and in all other respects comply with the procedure

in connection with such appeals laid down in the said Section and in the "Regulation relating to the Town Planning Appeals Board and the Hearing of Appeals."
