48. UKULAWULWA KOMSEBENZI

Noma ngabe ngubani owenza umsebenzi endaweni yamathuna uyaqashwa noma alawule ngokweneliseka komphathi.

49. UKULIMALA KWEZIKHUMBUZO

UMkhandlu awuyukhkhela ukulimala okwenzekile noma okungenzeka emsebenzini wesikhumbuzo nokungadalangwa ubudedengu babasebenzi boMkhandlu.

50. UKUSUSA KOMSEBENZI WESIKHUMBUZO

UMkhandlu, ngemuva kwesaziso, noma yingasiphi isikhathi ungashintsha ukuma komsebenzi wesikhumbuzo kunoma iyiphi indawo yamathuna.

51. UKULETHWA KWEMPAHLA ENDAWENI YAMATHUNA

Akukho mutu oyoletsha impahla endaweni yamathuna ngenhlosa yokuthi kwakhiwe umsebenzi wesikhumbuzo kunoma yiliphi ithuna ngaphandle —

- (a) kohlaka lwepelani okukhombisa ubunjalo bomsebenzi, imilobo kunjalo kanye nokuma kwawo kuhanjiswe kwaphinde kwavunywa umphathi wezemisebenzi yobunjiniyela;

- (b) kokuthi izimali ezidingekeyo mayelana nethuna sezikhokhiwe; futhi

- (c) noMkhandlu wavumelana nalokhu ngokubhaliwe.

52. UKUSUSA KOMSEBENZI WESIKHUMBUZO NGUMKHANDLU

Noma yimuphi umsebenzi obekiwe, owenziwe, oshintshiwe, ohlotshisiwe opendiwe ngokuphikisana nale Mithethodolobha noma ngokombono woMkhandlu owe phula indlela eyiyo yokuziphatha komphakathi, ungasuswa nguMkhandlu ngemuva kwesaziso, ngaphandle kokuthi kukhokhwe izinxephezelo.

53. OKUDINGEKAYO UKUZE KUGXUNYEKWE IMISEBENZI YEZIKHUMBUZO

(1) Noma ngubani ozogxumeka umsebenzi wesikhumbuzo kumele alandele lezidingo czilandelayo:

(a) Lapho ingxenyantha ethele yesikhumbuzo izoxunywa kunoma isiphi esinxe, noma ucingo, uphini wobukhulu obovu melekile nobude obanele kuyomele kesetshenziswe kulenhlosa kanti izinombolo lapho labo phini bezongena khona akumele ukuthi zishone ngaphansi kwamamilitha angama-50.

(b) Noma iyiphi ingxene yalomsebenzi, egxile emhlabathini noma etsheni noma yisiphi esinxe isisekelo iyoba isikwele iphinde yengezwe.

(c) Amatshe achazwe kwisigatshana (1) angeke abe nobukhulu obungalingani noma amakhona angalingani.

(d) Ingaphansi lanoma yisiphi isikhumbuzo kumele libe ngamamilimitha angama-50 ngaphansi kwelevele eyejwayelekile yengaphezulu lomhlaba noma ngaphezu kwamamilitha angama-200 ubukhulu.

(e) Awekho amatshe ohlobo oluthambile oluyosetshenziswe noluyevela ngaphezu kwamamilimitha angama-230 ngaphezu kwengaphezule lomhlabati noma ngaphezulu kwamamilimitha angama-200 ubukhulu.

(f) Wonke amakhanda kanye namatshe ayovikelwa ngokwanele kwingaphakathi ngekhopha eyindilinga.

(g) Wonke amatshe ayophakama ukufika emamillitheni ayi-150 ubukhulu ayobekwa ngokucophelela nangendlela eyiyo.

(h) Yonke imisebenzi yezikhumbuzo kuyomele eqedelwe kube ngokwanele emathuneni ngaphambi kokuthi ilethwe ngaphakathi emathuneni.

(i) Awekho amatshe athambile ayosebenziselwa umsebenzi wesikhumbuzo kanti imisebenzi yezikhumbuzo iyokhandwa noma yenziwe ngomabuli noma igrenayithi noma ngabe yiliphi elinye ilitshe elivunyelwe.

(j) Esimeni samathuna angawodwana, umzila uyona nengxene eyodwa eqinile.

(k) Akekho umuntu oyokwenza umsebenzi wamatshe, ukuxhoza, nokunye endaweni yamathuna nokungaxhumene nokumiswa komsebenzi wesikhumbuzo ngaphandle uma umsebenzi uvunyelwa ngokusemthethweni yile Mithethodolobha.

(l) Yonke imisebenzi yesikhumbuzo kuyomele ibe nesisekelo esiqinile netshe lasekhabda kanye nalapho kuhona ukuxunywa etsheni ele-seka ithuma emaceleni kanti konke ukuxunywa kumele kufakwe imotha kasemende eyiyo.

(m) Lapho la khona umsebenzi wesikhumbuzo unesisekelo phansi lesisekelo akumele sibe ngaphansi kwamamilimitha angama-900 ukunwe-beke bhayi ngaphansi kwamamilimitha angama-300 x 300.

(n) Bonke onkamisa kumsebenzi wesikhumbuzo kuyomele ukuthi baqoshwe kodwa bangaphumeli kwingaphezulu lesikhumbuzo.

(o) Ngemvume kasonkontileka, igama lomkhandi lingabhalwa kunoma yimuphi umsebenzi wesikhumbuzo, ngaphandle uma kungukuthi ikheli noma emine imininingwane ayinikezelwe.

54. IZIMOTO NAMATHULUZI

Noma ngabe yimuphi umuntu obandakanyekayo kunoma yimuphi umsebenzi uyozihlinzeka ngemoto, amathuluzi kanye nezinye izinto ezisebenza ngogesi nokungezakhe angazidzinga.

ISAHLUKO 8

55. UKWEHLUKANISA KWEZINDAWO ZAMATHUNA

UMkhandlu unelungelo lokuthi wehlukanise izindawo zamathuna ukuze zibe nendawo eyodwa noma eziningi zokungcwaba noma ubekele eceleni indawo yokungewaba abantu benko lo ethile kuphela.

56. INGXENYE YEZIKHUMBUZO

 - (d) Ngokwemigomo yesigaba 58 imisebenzi yezikhumbuzo ingenziwa ngemvume ebhalwe phansi yoMkhandlu, kunoma yiliph iethuna.
 - (e) Alikho itshe clyiobekwa ngendlela yokuthi liyoba ngamamilimitha angama-230 ngaphezelu komhlabathi liphinde libe ngaphezelu kwa-mamilimitha angama-200 ukushona phansi, ngaphandle kwemvume ebhaliwe yoMkhandlu.
 - (f) Wonke amatshe ayofakwa ngendlela ayoyivumela ukuba akhishwe kalula ngaphandle kobungozi bokuthi kulimale itshe lasekhanda, noma yimuphi omunye umsebenzi wesikhumbuzo ethuneni.
 - (g) Isilinganiso esivumelekile somsebenzi wetshe lesikhumbuzo elilodwa kumuntu omdala ngamamilimitha ayi-2500 x 1050.
 - (h) Isilinganiso esivumelekile somsebenzi wesikhumbuzo kumathuna ahamba ngamabili kubantu abadala ngamamilimitha ayi-2500 x 2250.
 - (i) Isilinganiso esivumelekile somsebenzi wesikhumbuzo sabantwana ngamamilimitha ayi-1500 x 900.

57. INGXENYE YOKUKHANGISA

- (1) Lezi zibonelo ezilandelayo zibhekele kwingxenye eyaziwa ngokuthi yindawo yokukhangisa:
 - (a) Ngaphandle kwezinsuku ezingama-28 ngemuva komngewabu ngokwesigatshana (5), akekho umuntu oyovunyelwa ukuthi abeke noma ashiye ethuneni okusacingo, izimbali, okokuhlobisa noma ngabe yini enye, ngaphandle kokuthi ngemuva kwezinyanga eziy-6 ngemuva kokuthi kungcwatshiwe, izimbali noma ezemvelo noma ezokwakhwa zihamba zodwa noma zisetsitsheni, noma ingasiphi isikhathi zingashiywa noma enhloko yethuna, uma ingakhandwe noma kuphi.
 - (b) UMkhandlu ungakhokhisa uphinde uthuthukise uphinde ugcine indawo yengadi engamamilimitha angama-300 ukuvuleka ngaphezu kobukhulu kulelo nalelo thuna kwingxenye yekhanda.
 - (c) Itshe lasekhanda kwingxenye yetshe lesikhumbuzo ayisoze yadlula emamlimitheni ayi-1070 kwinhloko noma kwileveli yaphansi, kanti futhi angeke kweqe kubukhulu bengxene yenhloko.
 - (d) Izilinganiso zesisekelo senhloko angeke zeqe emamlimitheni angama-600 ngaphezu komhlaba kumbe unqenqema kanti ukuma kwe-sisekelo ngaphezelu konqenqema kumele kube ngukuthi ichopho eduze kwethuna libe ngamamilimitha ayi-120 kusuka onqenqemeni, uma kungukuthi itshe lasekhanda ligxunyekwe nokuxhuma amathuna amabili lingadlula okungenani ngamamilimitha angama-600 ububanzi, kodwa angeke kweqe emamlimitheni ayi-1200 x 250.
 - (e) Kule ngxenye yesikhumbuzo, isitsha sezimbali esivunywe yilowo obhekile ukugcinwa kwamathuna singabekwa endaweni eyenzelwe lokhu, lesi sitsha kuyomele sibe kungenani ngamamilimitha angama-380 ubude singabi ngaphezu komgodi ubukhulu.

- (1) Lezi zinhlinzuko zibhekele ukusebenza kwezindawo zokukhangisa:

 - (b) Akukho ukwchlukaniswa kwamathuna kumbe ukwembozwu kwamathuna ngosemende okuyovunyelwa.
 - (c) Isisekelo setshe lethuna esigxunyekiwe noma esibekwe ngaphezelu kwethuna elilodwa siyoba ngamamilimitha angama-910 x 380 noma siphinde okungenani sijule ngamamilimitha angama-300.
 - (d) Isisekelo setshe lethuna elilodwa siyoba ngamamilimitha angama-910 x 250 ngokwesilinganiso.
 - (e) Isisekelo setshe lethuna ngalinye eligxunyekiwe elibekwi ngaphezelu kwamathuna amabili siyoba ngamamilimitha angama-2130 x 380 siphinde okungenani kube ngamamilimitha angama-300 ukushona phansi.
 - (f) Isisekelo sanoma yiliph iethuna lethuna elilodwa elimisiwe noma elibekwe ngaphezelu kwamathuna amabili siyoba ngamamilimitha ayi-1830 x 250 x 250 isilinganiso.
 - (g) Ukuze kwensiwe izibonelo zokufakwa kwezingqwembe zezinombolo kuyomele kube khona izimbobo ezingamamilitha ayi-6 ukuvuleka zibe ngamamilimitha angama-30 ukushona zibe ngamamilimitha angama-50 ukuhlukana kwisesekelo sanoma yiliph iethuna nangendlela yokuthi zonke izimbobo zibe phakathi nendawo yesisekelo ziphinde zibe ngamamilimitha angama-40 kusuka emngceleni wesisekelo ethuneni.
 - (h) Itshe lethuna elilodwa angeke limiswe kumbe lendlalwe lize lisabalale kumathuna amabili.
 - (i) UMkhandlu uyogcina uphinde uhlobise, njengokubona kwawo mahala, amathuna ngokuthi atshale izimbali kanye notshani.

59. INDAWO ELUNGISIWE

- (1) Lezi zibonelo zibhekela indawo elungisiwe:
 - (a) Akekho umuntu oyobeka, akhe amise, noma atshale noma ngabe noma yini, kubandakanya-imisbenzi yezikhumbuzo kanye nezimbali ngaphezelu noma ngasemathuneni, ngaphandle kokuthi izimbali zibekwe ngenyanga yokuqala emva komngewabu.
 - (b) Noma ngabe yini ebekiwe, yakhiwa, yamiswa noma yatshalwa ngaphezelu noma ngasethuneni noma yiliph, kubandakanya izimbali zamathuna noma izikhumbuzo esikhathini esiyinyanga kwangcwatshwa, ngokuphula isigatshana (1) kungasuswa uMkhandlu noma kusatshalaliswe noma kulahlwe.
 - (c) Isilinganiso esiphakathi nendawo sethuna lomuntu omdala singamamilimitha ayi-2500 x 1500 elomntwana ngamamilimitha ayi-1500 x 1000.
 - (d) Isilinganiso esiphakathi sokuvuleka kwethuna lomuntu omdala ngamamilimitha ayi-2200 ubude ngamamilimitha angama-900 ububanzi elomntwana ngamamilimitha ayi-1200 ubude x amamilimitha angama-700 ububanzi.
 - (e) Wonke umuntu ofuna ithuna lokungewaba umuntu omdala ongusayizi ongaphezelu kojwayelekile, kuyomele kuthi uma efaka isicelo sokungcwaba, abalule izilinganiso zebhokisi abandakanye nokuphakama.
 - (f) Isikhumbuzo semabhula esingamamilimitha angama-305 x 210 ngesilinganiso singabekwa ethuneni kwingandi yesikhumbuzo.
 - (g) Uqwembe lwasikhumbuzo lubekwa lunqume kabilo kusemende ongamamilimitha angama-355 x 260 (ubukhulu) nokuphakama okungan-go kuphakama kwengaphezelu lenhlabathi.
 - (h) Izingqwembe zesikhumbuzo zibekwa maphakathi nendawo ethuneni ukuze zonke zenze ulayini ogondile.
