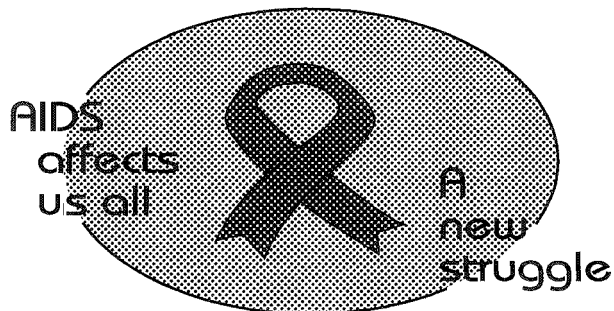

**No. 25****2 October 2007****NOTICE IN TERMS OF SECTION 114 OF THE KWAZULU-NATAL PUBLIC TRANSPORT ACT, 2005 (ACT NO. 3 OF 2005)**

I, Bhelokwakhe Hamilton Cele, by the power vested in me in terms of section 114 of the KwaZulu-Natal Public Transport Act, 2005 (Act No. 3 of 2005) as the Member of the Executive Council of the Province of KwaZulu-Natal responsible for Transport, hereby declare the following areas –

- (i) Vulindlela Suburb;
- (ii) Eskhawini Township,

as transport crisis areas.
