PROCEED WITH TOLL ROAD THROUGH SOUTHBROOM, PICK UP AND DROP OFF SOUTHBROOM. PROCEED ALONG R620 TOWARDS PORT EDWARD, PICK UP AND DROP OFF MARINA BEACH. PROCEED WITH THE R620 TOWARDS SAN LAMEER, PICK UP AND DROP OFF AT SAN LAMEER. PROCEED ON THE R620 TOWARDS TRAFALGAR, PICK AND DROP OFF AT TRAFALGAR. **4. PORT EDWARD TO WOZA / NZIMAKWE ROUTE**

PORT EDWARD TAXI RANK TURN RIGHT INTO MAIN ROAD ROBOTS. PROCEED R61 TOLL TOWARDS MARGATE, PROCEED R61 PASS PALM BEACH, TURN LEFT TOWARDS IZINGOLWENI, NZIMAKWE ROAD – TARR ROAD. PROCEED TO THE OLD MUNSTER ROAD – MUNSTER SHOPPING CENTRE, TURN RIGHT INTO IZINGOLWENI GRAVEL ROAD PASS JERICHO STORE, PICK UP AND DROP OFF AT GATE STORE, TONGASI ROAD D1097, TURN RIGHT D0861 – WOZA ROAD. PROCEED STRAIGHT ALONG WOZA ROAD, TURN LEFT TO PORT EDWARD TAXI RANK.

**5. PORT EDWARD / XOLO / GCILIMA ROUTE**

PORT EDWARD TAXI RANK TOWARDS XOLO ROUTE TRIBAL AREA, PORT EDWARD / IZINGOLWENI TARR ROAD, TURN RIGHT PENDUKA TOWARDS GCILIMA AND TOWARDS MARGATE TAXI RANK. PROCEED WITH GRAVEL ROAD – PENDUKA MANZAMHLOPE GRAVEL ROAD. PROCEED PASS JABULANI STORE D1095 GRAVEL XOLO SERVICE GRAVEL ROAD. PROCEED ALONG TOWARDS GCILIMA, KWA MKHIZE STORE – DROP OFF AND PICK UP, TURN LEFT TO D1092 NKONENI, TURN AROUND AT NKONENI / TUTUKA TAXI RANK, TURN RIGHT – OKHUSHWINI GRAVEL ROAD, THOKOTHE ROAD – SERVICE ROAD, DELIHLAZO TAXI RANK, TURN AROUND SAME ROUTE BACK.

**6. MARGATE – GCILIMA ROUTE**

GCILIMA TAXI RANK, GCILIMA ROAD, MARGATE, SERVICE – TURN LEFT NKAMPINI – MMBAMBI HIGH SCHOOL PICK UP AND DROP OFF, MQADI STOPPING ZONE, TURN RIGHT D203 – BHODISA, STOP AT MHLABULUNGILE SCHOOL, THANDOKULE / SHAKA STORE DROP OFF AND PICK UP. PROCEED ALONG D203, TURN LEFT R61 TOWARDS MARGATE, TURN LEFT AT RAMSGATE TURN OFF, TURN RIGHT AT ALFORD AVENUE, TURN LEFT IN MARINE DRIVE, TURN RIGHT INTO EMOYENI TAXI RANK, RETURN OPPOSITE ROUTE BACK.

**7. MARGATE TAXI RANK TO GCILIMA ROUTE**

FROM MARGATE TAXI RANK TURN LEFT IN R61 MARINE DRIVE. PROCEED ON THE R61 TOWARDS RAMSGATE, USE OLD RAMSGATE ROAD – R620 AT SOUTHBROOM, TURN RIGHT INTO BUSHY VALE NO.1. PROCEED ON GRAVEL ROAD, CME OUT AT BUSHY VALE NO. 3 D337 – MARINA BEACH, PICK UP AT

GCILIMA PHATHWA HIGH SCHOOL, TURN ON THE R102 MARINA BEACH, PICK AND DROP OFF ZONE AT SOUTHBROOM, TURN LEFT ON THE R102 TO RAMSGATE, TAKE RAMSGATE TURN OFF ON TOLL ROAD, TURN RIGHT AT ALFORD AVENUE, TURN LEFT IN R61 MARINE DRIVE, TURN RIGHT INTO EMOYENI TAXI RANK.

**8. MARGATE TAXI RANK TO MARGATE EXT. 3 AND 7 ROUTE**

MARGATE EXT.3 TOWARDS MARGATE TAXI RANK, LEFT WARTSKI DRIVE – PROCEED SHEPSTONE ROAD ALL ALONG TEDDER AVENUE TOWARDS AIRPORT, TURN RIGHT INTO LIVINGSTONE ROAD, LEFT AND RIGHT INTO DEWET STREET, TURN LEFT INTO TEDDER, BOBBY LOCK AVENUE, TURN RIGHT INTO LOUIS BOTHA AVENUE, TURN LEFT AND RIGHT INTO TEDDER AVENUE – STRAIGHT LOUIS BOTHA AVENUE, TURN LEFT INTO DAVID STREET, TURN RIGHT ARTHUR STREET, TURN LEFT INTO LOUIS BOTHA AVENUE, TURN LEFT INTO LAVENSKI DRIVE, TURN LEFT INTO ROSSEVELDT SERVICE THE WHOLE EXT.3, INTO LEFT RIGHT IN PIET RETIEF ROAD. PROCEED STRAIGHT WITH ROSSEVELDT ROAD, TURN RIGHT JELICO TO EXT.7, TURN LEFT INTO ALEXANDER AVENUE, TURN RIGHT – WINGATE AVENUE TO EXT.7 SERVICE FLAMBOYANT STREET, TURN RIGHT, TURN LEFT – SPCA ROAD AND ALSO RIGHT INTO BAHANSTI, WINGATE AVENUE, TURN LEFT INTO SERVICE BAKER STREET, TURN LEFT FROM WINGATE INTO OATLANDS ROAD TOWARDS RAMSGATE, DROP OFF AND PICK UP AT MARGATE TEXTILES, STRAIGHT WITH RAMSGATE – OATLANDS ROAD, DROP OFF MARGATE TEXTILES, TURN LEFT INTO RAMSGATE TOWARDS FASCADALE ROAD, TURN LEFT – SOUTHBROOM TOWARDS RAMSGATE – MARGATE OLD ROAD, TURN LEFT – PIONEER ROAD, TOMLY RIGHT, LEFT OUT OF PIONEER ROAD INTO JULIA AND CAPTAIN DAVIES, LEFT AND RIGHT JOHN CAVE. PROCEED TOWARDS ROADS CHIDDINGSTON, TURN RIGHT INTO GLENMARKE, TURN RIGHT – MARINE DRIVE R61 TOWARDS SOUTHBROOM, LEFT SHIRLEY AVENUE, LEFT INTO BEACH ROAD AND BACK TO MARINE DRIVE, LEFT SHOE ROAD.

**9. MARGATE – SOUTHBROOM ROUTE**

(OLD ROAD TO SOUTHBROOM), LEFT IMPIR ROAD, TURN RIGHT INTO PIONEER ROAD, TURN LEFT IN LINK ROAD (RAMSGATE TO SOUTHBROOM) GRAVEL ROAD, PICK UP AND DROP OFF – PISTOL SALOON. PROCEED STRAIGHT – OLD ROAD RAMSGATE – SOUTHBROOM, TURN RIGHT INTO R61, STRAIGHT INTO SOUTHBROOM AVENUE, PICK UP AND DROP OFF CBD, TURN RIGHT INTO EAGLE STREET, PICK UP AND DROP OFF SOUTHBROOM GOLF CLUB, TURN RIGHT AND LEFT CAPTAINSMITH STREET, TURN LEFT INTO LINK ROAD AND CAPTAINSMITH ROAD. PROCEED STRAIGHT WITH CAPTAINSMITH STREET, TURN RIGHT INTO OUTLOOK ROAD, TURN LEFT EYLES ROAD, TURN LEFT R61 TOWARDS MARINA BEACH, TURN LEFT MARINA BEACH ROAD INTO GEORGE TONTIULTI ROAD, TURN AROUND AT THE BEACH, TURN RIGHT R61 – TURN LEFT MARINE TOWARDS MARGATE TAXI ROUTE (R61 TAKE RAMSGATE OFF RAMP – TURN RIGHT INTO ALFORD AVENUE – TURN LEFT INTO R61 MARINE DRIVE – TURN RIGHT INTO MARGATE TAXI RANK.)

**10. MARGATE – BIZANA ROUTE**

MARGATE TAXI RANK, TURN LEFT IN MARINE DRIVE – R620, STRAIGHT MARINE DRIVE, TURN RIGHT IN ALFORD AVENUE, TURN LEFT ONTO TOLL ROAD – R61, STRAIGHT ALL ALONG TO R61 TOWARDS BIZANA, R61 ALL ALONG PASS SOUTHBROOM, PICK UP AT SOUTHBROOM BUS STOP TAXI LAY BYS MARINE BEACH, PALM BEACH, PORT EDWARD, BANNERS REST VILLAGE DROP OFF AND PICK UP ZONE, WILD COAST CASINO PICK UP AND DROP OFF IZIKHUBA DROP OFF AND PICK UP R61 KWAPLEPELE PICK UP AND DROP OFF ZONE, TRAFALGAR DROP OFF AND PICK UP ZONE ESTHENI STOP – PICK UP AND DROP OFF ZONE R61, PROCEED STRAIGHT TO BIZANA BHINIZA STATION PICK UP AND DROP OFF, SEAVIEW DROP AND PICK UP ZONE, MTHENTU STOP – PICK UP AND DROP OFF, KLWAHLUBISA STORE PICK UP AND DROP OFF ZONE, ALL SAINTS MISSION – PICK UP AND DROP OFF ZONE, NTHLAKWE PICK UP AND DROP OFF ZONE, STOP AT BIZANA TAXI RANK. SAME ROUTE BACK TO MARGATE TAXI RANK.

**11. PORT EDWARD - BIZANA**

TURN RIGHT R61 TOWARDS BIZANA, PROCEED STRAIGHT ON R61 TO BIZANA, BANNERS REST VILLAGE DROP OFF AND PICK UP ZONE, PICK UP AND DROP OFF AT WILD COAST SUN, ETSHENI STOP PICK UP AND DROP OFF. PROCEED R61 STRAIGHT TO BIZANE, BHINIZA STATION – RANK PICK UP, SEAVIEW PICK UP AND DROP OFF, MTHENTU STOP – PICK UP AND DROP OFF, KHWAHLUBISA STORE PICK UP AND DROP OFF, ALL SAINTS MISSION DROP OFF AND PICK UP, NTHLAKWE PICK UP AND DROP OFF, STOP AT BIZANA TAXI RANK. SAME ROUTE BACK TO PORT EDWARD TAXI RANK.

**12. NZIMAKWE – PORT EDWARD ROUTE**

PORT EDWARD TAXI RANK, TURN LEFT INTO R612 – TOWARDS MARGATE, TURN LEFT INTO NZIMAKWE RING ROAD SERVICE THE NEW NZIMAKWE SUBURB.

**13. MARGATE – MVUSHINI ROUTE**

TURN LEFT INTO MARINE DRIVE, PROCEED STRAIGHT INTO MARINE DRIVE, TURN RIGHT INTO FASCADALE ROAD, TURN RIGHT INTO GRAVEL ROAD – OATSLANDS – TOWARDS GAMALAKHE, TURN RIGHT INTO D1097,

TURN LEFT INTO D1091 AT BUNGANI STORE. PROCEED STRAIGHT INTO GRAVEL ROAD, PICK UP AND DROP OFF AT THE STAR POINTS RANK, MVUTSHINI STOP - DROP OFF AND PICK UP, WILTON ROAD – PROCEED LEFT STOP AT MBHELE STOP – PICK UP AND DROP OFF POINTS, TURN RIGHT MANKUTSHANE ROAD GRAVEL, TURN AROUND AT MANKUTSHANE RANK. SAME ROUTE BACK TO MARGATE.

#### **14. MARGATE - LAMONT ROUTE**

FROM MANKUTSHANE RANK, TURN RIGHT GRAVEL ROAD D1091, STOP MONDE HIGH SCHOOL. PROCEED ALONG D1091 GRAVEL ROAD, DLAMINI STOP PICK AND DROP OFF, MTHOMBOIHI SCHOOL STOPPING ZONE. PROCEED ALONG TO LUDIMOLA CLINIC – PICK AND DROP OFF ZONE, LAMONG BIG STOP – DROP OFF AND PICK UP – DIP TANK, TURN OFF TO SERVICE ROAD NQMWEMABALA, TURN RIGHT TOWARDS SUNDUZA ROAD. PROCEED STRAIGHT WITH DINGSTONE GRAVEL ROAD, TURN AROUND AT SUNDUZA TAXI RANK. USE THE SAME ROUTE BACK TO MARGATE TAXI RANK.

#### **15. MARGATE – NOSITHA ROUTE**

MARGATE TAXI RANK – TURN RIGHT INTO MARINE DRIVE, TURN LEFT IN WARTSKI DRIVE THEN PROCEED ALONG WARTSKI DRIVE, TURN LEFT INTO LOUIS BOTHA AVENUE, TURN LEFT INTO LOUIS BOTHA AVENUE, TURN RIGHT AT BOBBYLOCK INTO GAMALAKHE AND OATSLANDS ROAD, TURN RIGHT INTO D337 TOWARDS NOSITHA, TURN LEFT AT JERICHO ROAD TOWARDS NOSITHA, TURN RIGHT AT D337 TOWARDS NOSITHA, STOP AND PICK UP AT UVONGI RIVER. PROCEED ON THE NOSITHA GRAVEL ROAD, PICK UP AND DROP OFF AT THE NOSITHA PRIMARY. PROCEED TO NOSITHA BIG RANK, TURN AROUND AT TAXI RANK. USE THE SAME ROUTE BACK.

#### **16. MARGATE – PORT SHEPSTONE ROUTE**

TURN RIGHT IN MARINE DRIVE – R61, PROCEED WITH MARINE DRIVE TOWARDS SHELLY BEACH, MANABA PICK UP ON MARINE DRIVE – GOLDEN MOON, DROP OFF IN MARINE DRIVE – UVONGO BUS STOP UVONGO – MARINE DRIVE PICK UP AND DROP OFF AT ST. MICHAELS-ON-SEA. PROCEED MARINE DRIVE R61 TOWARDS SHELLY BEACH, STOP AT ABRIE SPIES MARINE DRIVE AT PICK UP AND DROP OFF ZONE. PROCEED WITH MARINE DRIVE, STOP AND PICK UP IN MARINE DRIVE (OLD DRIVE-IN). PROCEED WITH MARINE DRIVE – PICK UP AND DROP OFF AT OLD MCDONALDS FARM, STOP AND DROP OFF AT PORT SHEPSTONE TECHNIKON. PROCEED WITH THE R61 – TURN RIGHT AT QUARRY ROAD INTERSECTION, TURN LEFT IN BAZELY ROAD, TURN LEFT IN CONNER STREET, TURN RIGHT IN MCARTHUR STREET, TURN RIGHT IN DENNIS SHEPSTONE, TURN LEFT IN RYDER STREET ACROSS NELSON MANDELA DRIVE INTO PORT SHEPSTONE TAXI RANK. SAME ROUTE BACK.

#### **17. PORT EDWARD, BHAMBULA (P69) MARGATE TAXI RANK (R61) TO DURBAN ROUTE**

FROM PORT EDWARD TAXI RANK TO BHAMBULA – P69, NZIMAKWE ROAD, MARGATE TAXI RANK, PROSPECTION (OFF LOADING), REUNION TO M4 WEMA TO MARKET STREET TO DURBAN RANK 59 AND RETURN.

#### **18. MARGATE TO DURBAN ROUTE**

FROM MARGATE TAXI RANK – JOIN R620 PROCEED ALONG MARINE DRIVE, SHELLY BEACH, NATIONAL ROAD, PORT SHEPSTONE PROVINCIAL HOSPITAL, ISIPINGO ROAD, REUNION, WEMA TO MARKET STREET (RANK 59) AND RETURN (LOADING AND OFF LOADING).
