

In terms of Section 18(3) of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998) the MEC responsible for local government has determined that the municipal council consists of 34 councillors.

After having consulted the Independent Electoral Commission, The Municipal Demarcation Board has delimited the municipality into 17 wards in terms of Schedule 1 to the Act.

The number of registered voters in each ward does not vary by more than fifteen percent from the norm. The norm was determined by dividing the total number of voters on the municipal segment of the national common voters roll, namely 61462 voters on 12 February 2009, by the number of wards in the municipality.

An overview map of the boundary of the municipality, with the boundaries of the wards within the municipal boundary, and a map of each ward are attached. In case of a discrepancy between a map and this schedule, the map will prevail.
