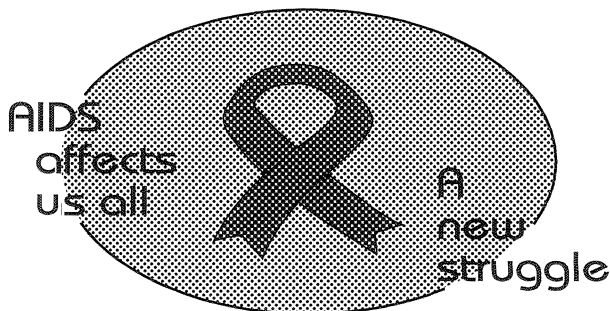

CONDITIONS FOR PUBLICATION OF NOTICES

CLOSING TIMES FOR THE ACCEPTANCE OF NOTICES

1. (1) The *KwaZulu-Natal Provincial Gazette* is published every week on Thursday, and the closing time for the acceptance of notices which have to appear in the *KwaZulu-Natal Provincial Gazette* on any particular Thursday, is **15:00 one week prior to the publication date**. Should any Thursday coincide with a public holiday, the publication date remains unchanged. However, the closing date for acceptance of advertisements moves backwards accordingly, in order to allow for 5 working days prior to the publication date.
- (2) The date for the publication of an **Extraordinary** *KwaZulu-Natal Province Provincial Gazette* is negotiable.
2. (1) Notices received **after closing time** will be held over for publication in the next *KwaZulu-Natal Provincial Gazette*.
- (2) Amendments or changes in notices cannot be undertaken unless instructions are received **before 10:00 on Fridays**.
- (3) Notices for publication or amendments of original copy can not be accepted over the telephone and must be brought about by letter, by fax or by hand. The Government Printer will not be liable for any amendments done erroneously.
- (4) In the case of cancellations a refund of the cost of a notice will be considered only if the instruction to cancel has been received on or before the stipulated closing time as indicated in paragraph 2(2).

APPROVAL OF NOTICES (This only applies to Private Companies)

3. In the event where a cheque, submitted by an advertiser to the Government Printer as payment, is dishonoured, then the Government Printer reserves the right to refuse such client further access to the *KwaZulu-Natal Provincial Gazette* until any outstanding debts to the Government Printer is settled in full.

THE GOVERNMENT PRINTER INDEMNIFIED AGAINST LIABILITY

4. The Government Printer will assume no liability in respect of—
 - (1) any delay in the publication of a notice or publication of such notice on any date other than that stipulated by the advertiser;
 - (2) erroneous classification of a notice, or the placement of such notice in any section or under any heading other than the section or heading stipulated by the advertiser;

- (3) any editing, revision, omission, typographical errors, amendments to copies or errors resulting from faint or indistinct copy.

LIABILITY OF ADVERTISER

5. Advertisers will be held liable for any compensation and costs arising from any action which may be instituted against the Government Printer in consequence of the publication of any notice.

COPY

6. Notices must be typed on one side of the paper only and may not constitute part of any covering letter or document.
7. At the top of any copy, and set well apart from the notice, the following must be stated:

Where applicable

- (1) The heading under which the notice is to appear.
- (2) The cost of publication applicable to the notice, in accordance with the "Word Count Table".

PAYMENT OF COST (This only applies to Private Companies)

9. **With effect from 26 April 2007 no notice will be accepted for publication unless the cost of the insertion(s) is prepaid in CASH or by CHEQUE or POSTAL ORDERS. It can be arranged that money can be paid into the banking account of the Government Printer, in which case the deposit slip accompanies the advertisement before publication thereof.**
10. (1) The cost of a notice must be calculated by the advertiser in accordance with the word count table.

(2) Where there is any doubt about the cost of publication of a notice, and in the case of copy, an enquiry, accompanied by the relevant copy, should be addressed to the **Advertising Section, Government Printing Works, Private Bag X85, Pretoria, 0001 [Fax: (012) 323-8805], before publication.**
11. Overpayment resulting from miscalculation on the part of the advertiser of the cost of publication of a notice will not be refunded, unless the advertiser furnishes adequate reasons why such miscalculation occurred. AMENDMENT TO THE NUISANCE BYLAWS

The uMhlathuze Municipality has, in terms of Section 156 of the Constitution, 1996 (Act No 108 of 1996) read in conjunction with section 12(3) of the Local Government: Municipal Systems Act, 2000 (Act No 32 of 2000), passed a resolution for the amendment of the Environmental Health Services Bylaws. The following are the applicable amendments to the Nuisance Bylaws as promulgated in the Provincial Gazette Number 6284 under Notice Number 20 dated 19 June 2003, which shall come into operation on the date of publication hereof:

1. the following amendments to the Nuisance Bylaws promulgated in the Provincial Gazette Number 6284 under notice number 20 dated 19 June 2003 be approved and thereafter be published for public comment in terms of Section 12(3) (b) of the Local Government: Municipal Systems Act, 2000 (Act No 32 of 2000) :

- 1.1 Delete the word "**Director: Corporate Services**" from the Definition section as well as throughout the Nuisance Bylaw document and replace it with "**Senior Manager: Corporate Services**";

The purpose of the replacement will provide for the correct designation, to be in line with the Organisational designations as approved by Council.

The new definition will read as follows:

"Senior Manager: Corporate Services" means the person appointed as Senior Manager: Corporate Services by the Council or any other person lawfully acting in that capacity;

- 1.2 Insert the following clause as number (10) under the "**USE OF STREETS AND PUBLIC FOOTPATHS**"

"A person may not repair a motor vehicle for the purpose of an informal mechanic on any street, public footpath, verge or public place if the place has not been duly designated for such purpose."

The purpose of this insertion seeks to prevent and control illegal and informal mechanics that are in operation in the City of uMhlathuze;

- 1.3 Insert the following clause as number (6) under "**GENERAL**"

"A person may not park any vehicles, including trucks, on an open space, park or pavement. Trucks over nine (9) ton may not be parked anywhere in residential areas, except for delivery purposes."

The purpose of the insertion seeks to prevent such an activity from carrying on as it is also in contravention of the uMhlathuze Town Planning Scheme.

AMENDMENT TO THE ENVIRONMENTAL HEALTH SERVICES BYLAWS

The uMhlathuze Municipality has, in terms of Section 156 of the Constitution, 1996 (Act No 108 of 1996) read in conjunction with section 12(3) of the Local Government: Municipal Systems Act, 2000 (Act No 32 of 2000), passed a resolution for the amendment of the Environmental Health Services Bylaws. The following are the applicable amendments to the Environmental Health Services Bylaws as promulgated in the Provincial Gazette Number 6508 under Notice Number 16 dated 14 September 2006, which shall come into operation on the date of publication hereof:

- 1 Insert the following definition under Section 70 (Definition Section):

"health care waste" means waste originating from health care establishment consists of health care risk waste and health care general waste.

The purpose for the insertion is to provide better understanding, as well as the correct meaning of health care waste.

The new clause shall read as follows:

"health care waste" means waste originating from health care establishment and it consists of health care risk waste and health care general waste;

- 1.2 Insert the following definition under Section 70 (Definition Section):

"health care risk waste" (HCRW) means the following categories of waste:

- (a) Infectious waste
- (b) Pathological waste
- (c) Sharp waste
- (d) Pharmaceutical waste
- (e) Genotoxic waste
- (f) Chemical waste
- (g) Waste with heavy metals
- (h) Pressurised container waste
- (i) Radioactive waste

It should be noted that the definitions for the above terms remain as is in the Bylaws under Section 70, with the exclusion of general waste, as it will be redefined and shall not form part of the categories of **"health care risk waste"**.

The purpose of the insertion is to include the term "RISK" in order to provide emphasis;

- 1.3 Insert the following words before the word general waste under Section 70 (e) (Definition Section):

“health care”

The purpose of the insertion is to provide an emphasis, and proper meaning.

The new definition will be the following:

“health care general waste” Denotes a generic term for waste that, because of its composition and characteristics, does not pose a significant risk to public health or the environment, if managed properly. This waste type typically consists of plastics, paper, food and liquids not considered to be infectious or contaminated with hazardous chemicals or radioactivity;

- 1.4 Insert the word “RISK” anywhere where the following words appear “health care waste”, to read as follows:

“health care **risk** waste”

The above change should be effected in the entire Chapter 14.

The purpose of this insertion is to provide the emphasis in order to assist during the enforcement stage.
