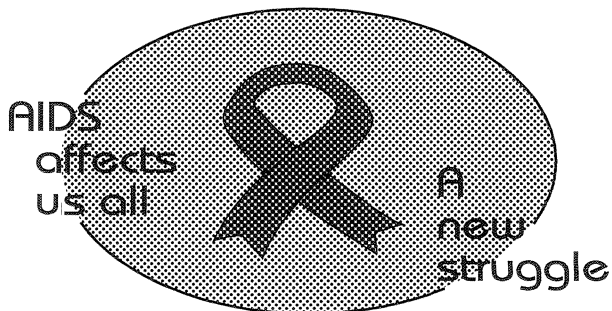



KWAZULU-NATAL TRADITIONAL LEADERSHIP AND GOVERNANCE ACT, 2005**

I hereby amend the regulations made in terms of section 44(2) of KwaZulu-Natal Traditional Leadership and Governance Act, 2005 (Act No. 5 of 2005), as set out in the Schedule hereto.

SCHEDULE**Definitions**

1. In these Regulations "the Regulations" means the KwaZulu-Natal Traditional Leadership Regulations published by Provincial Notice No. 1646 on 15 September 2006.

Amendment of Regulation 17

2. Regulation 17 of the Regulations is hereby amended by the substitution for sub-regulation (1) of the following sub-regulation:

"~~[(1)]~~ This part will, with the necessary changes, apply to—

- (a) the election of traditional councils;
- (b) the election of the executive committees of local houses;
- (c) the election of the members of local houses to the Provincial House; ~~[and]~~
- (d) the election of the executive committee of the Provincial House~~[,]~~; ~~and~~
- (e) the election of *iziphakanyiswa*: Provided that —
 - (i) *imbizo* to nominate and elect *iziphakanyiswa* must be called by the MEC in the election timetable contemplated in regulation 19(3); and
 - (ii) must be presided over by the independent election agency contemplated in regulation 18, on a date prior to the date of the election of the relevant traditional council."

Amendment of Regulation 22

3. Regulation 22 of the regulations is hereby amended by the substitution for sub-regulation (2) of the following sub-regulation:

"(2) Candidates who are proposed for election in terms of section 6(3)~~[(6)b]~~ of the Act, read with regulation 8, ~~[are orally] must be~~ proposed and seconded ~~[by a show of hands]~~ by the proposer and at least two seconders, all of whom are registered voters from that traditional community, and who are present at the *imbizo* ~~[in writing, in the manner contemplated in this regulation: Provided that —~~

- (a) the independent election agency must, from the voter's roll, confirm that the proposer and the seconders are registered voters from that traditional community, and are present at the *imbizo*; and
- (b) the names of the proposer and the seconders must remain confidential, and may not be made public at the said *imbizo*."

Short title and commencement

4. These Regulations are called the KwaZulu-Natal Traditional Leadership Amendment Regulations, 2011
