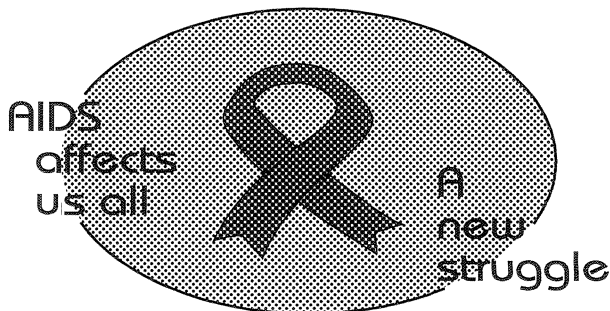

**DEPARTMENT OF CO-OPERATIVE GOVERNANCE AND TRADITIONAL AFFAIRS****NOTICE IN TERMS OF SECTION 16(3)(c) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT NO. 117 OF 1998): UBUHLEBEZWE, uMSHWATHI AND eDUMBE MUNICIPALITIES**

1. The Member of the KwaZulu-Natal Executive Council responsible for Local Government, in her capacity as a Member of the Executive Council responsible for Co-operative Governance, and under the powers vested in her by section 16(1) of the Local Government Structures Act, 1998 (Act No. 117 of 1998), to amend the notice issued in terms of section 12 of the said Act, and in order to give effect to decisions by the Municipal Councils of the Ubhlebezwe, uMshwathi and eDumbe Municipalities to designate certain councillors as full-time, proposes to publish the following notice:
