

PROPOSED NOTICE IN TERMS OF SECTION 16(3)(c) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998: KWA SANI MUNICIPALITY

The Member of the KwaZulu-Natal Executive Council responsible for local government, under the powers vested in her by section 16(1) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), to amend the notice issued in terms of section 12 of the said Act, and in order to give effect to a decision by the Municipal Council to change the type of the Kwa Sani Municipality from a municipality with a plenary executive system to a municipality with a plenary executive system combined with a ward-participatory system, proposes to publish the following notice, amending the relevant paragraph of Provincial Notice No. 344 dated 19 September 2000, published in Provincial *Gazette* No. 5563.
 - "I, Nomusa Dube, in my capacity as Member of the KwaZulu-Natal Executive Council responsible for local government, and under powers vested in me by section 16(1)(a) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), hereby amend Provincial Notice No. 344 of 2000, published on 19 September 2000 in Provincial Gazette No. 5563, by the insertion in Item 3 of Part 4 after the word 'system': the words 'combined with a ward-participatory system'".
