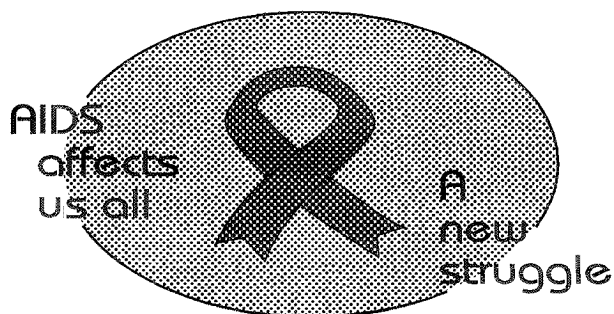

Notice is hereby given in terms of Section 49(1)(a)(i) read together with Section 78(2) of the Local Government Municipal Property Rates Act, 2004 (Act No. 6 of 2004), herein referred to as the “Act”, that the valuation roll effective 1 July 2012 is open for public inspection at the Council offices in New Hanover, Wartburg and Cool Air from 09 May 2012 to 08 June 2012 during normal office hours (7:30a.m. to 04:00p.m).

An invitation is hereby made in terms of Section 49(1)(a)(ii) read together with Section 78(2) of the Act that any owner property or person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the valuation roll within the above mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such.

In terms of Section 71 of the Act “when an appeal board gives a decision it may issue an order with regards to costs it regards as just and equitable”.

In terms of Section 72 of the said Act, “when making an order in terms of sub-section 1, an appeal board may order any person whose appeal or an opposition to an appeal is in bad faith or frivolous to compensate the municipality concerned in, full or part for costs incurred by the Municipality in connection with the appeal”.

The form for the lodging of an objection is obtainable from the uMshwathi Municipal Offices in Main Road, New Hanover.
