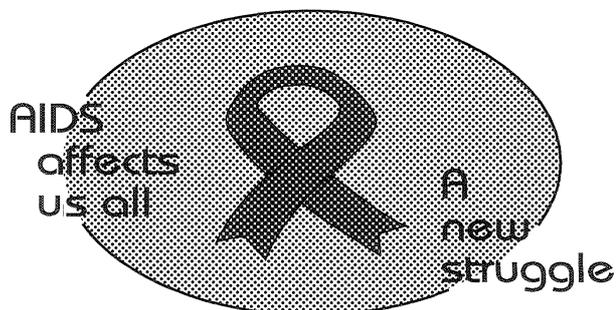

#### **PUBLIC NOTICE TO ALL PROPERTY OWNERS: EXTENSION OF DEADLINE FOR SUBMISSION OF OBJECTIONS TO NEW GENERAL VALUATION ROLL EFFECTIVE 1 JULY 2012**

Further to the revised Notice issued to members of the public regarding the inspection of the Valuation Roll for the financial years 1 July 2012 to 30 June 2016, members of the public are further informed that the period for objections in terms of Section 50 of the Municipal Property Rates Act, 2004 (Act No. 6 of 2004) has been extended from 13 April 2012 to 2 May 2012.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such. The form for the lodging of an objection is obtainable at: The Municipal Offices situated at the corner of Airth and Williamson Streets, Scottburgh, 4180 or the website [www.umdoni.gov.za](http://www.umdoni.gov.za). The completed forms must be returned to the street address in Scottburgh or posted by registered mail to: The Municipal Manager, Umdoni Municipality, P O Box 19, Scottburgh, 4180 or hand delivered to The Municipal Offices based at corner of Airth and Williamson Streets, Scottburgh, 4180.
