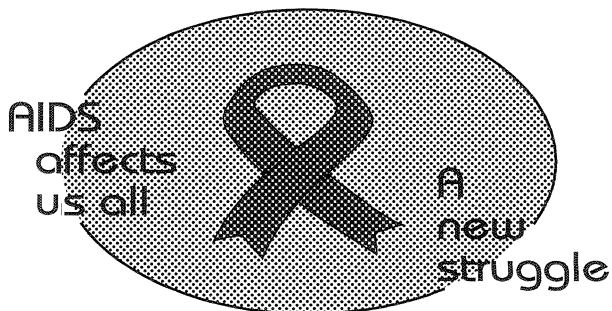

CLOSING TIMES FOR THE ACCEPTANCE OF NOTICES

1. (1) The *KwaZulu-Natal Provincial Gazette* is published every week on Thursday, and the closing time for the acceptance of notices which have to appear in the *KwaZulu-Natal Provincial Gazette* on any particular Thursday, is **15:00 one week prior to the publication date**. Should any Thursday coincide with a public holiday, the publication date remains unchanged. However, the closing date for acceptance of advertisements moves backwards accordingly, in order to allow for 5 working days prior to the publication date.
- (2) The date for the publication of an **Extraordinary** *KwaZulu-Natal Province Provincial Gazette* is negotiable.
2. (1) Notices received **after closing time** will be held over for publication in the next *KwaZulu-Natal Provincial Gazette*.
- (2) Amendments or changes in notices cannot be undertaken unless instructions are received **before 10:00 on Fridays**.
- (3) Notices for publication or amendments of original copy can not be accepted over the telephone and must be brought about by letter, by fax or by hand. The Government Printer will not be liable for any amendments done erroneously.
- (4) In the case of cancellations a refund of the cost of a notice will be considered only if the instruction to cancel has been received on or before the stipulated closing time as indicated in paragraph 2(2).

APPROVAL OF NOTICES (This only applies to Private Companies)

3. **NOMINATION OF PERSONS TO BE APPOINTED TO THE KWAZULU-NATAL
NATURE CONSERVATION BOARD**

The KwaZulu-Natal Nature Conservation Board is the successor in title to the Natal Parks Board and the Directorate: Nature Conservation. The primary functions of the Board are to direct the management of nature conservation within the Province and protected areas; to develop and promote ecotourism within the protected areas and to develop and promote conservation partnerships with people in KwaZulu-Natal.

In terms of Section 4(4) of the KwaZulu-Natal Nature Conservation Management Act 9 of 1997, I hereby invite written nominations with motivation, from members of the public, and/or organisations for persons who could be considered for appointment to vacancies on the KwaZulu-Natal Nature Conservation Board. Proposed persons must have an interest in nature conservation and must be drawn from categories mentioned in Section 4 of the Act, which are currently vacant and which are summarised below:

- (i) Section 4(8)(a)(ii) At least one, but not more than two persons from non-governmental organisations, institutions or groups established for the advancement of nature conservation or environmental protection within the province;
- (ii) Section 4(8)(b)(iii) One person with knowledge and experience of environmental law;
- (iii) Section 4(8)(b)(iv) One person nominated by the Provincial Tourism Authority;

I am seeking to appoint Board Members to the categories as set out above.

A person cannot be appointed as a member of the Board if such a person-

- (i) is or becomes a member of the National or Provincial Parliaments, or an official or employee contemplated in the Public Service Act, or, save for the Chief Executive Officer contemplated in terms of Subsection (10), a member of the Conservation Service;
- (ii) is an unrehabilitated insolvent, or becomes insolvent and the insolvency results in the sequestration of his or her estate;
- (iii) is declared to be of unsound mind by a court of the Republic; or
- (iv) since the date on which the Constitution came into effect, has been or is convicted of an offence and sentenced to more than 12 months' imprisonment without the option of a fine, either in the Republic, or outside the Republic if the conduct constituting the offence would have been an offence in the Republic, but no one may be regarded as having been sentenced until an appeal against the conviction or sentence has been determined, or until the time for an appeal has expired. A disqualification under this paragraph ends five years after the sentence has been completed.

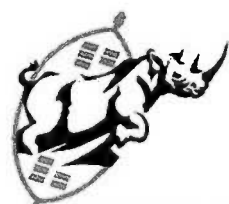
Persons shall be appointed for a period of three (3) years or such lesser period as I, BM Radebe, MEC for Agriculture and Environmental Affairs may determine, in terms of Section 6 of the Act.

Die KwaZulu-Natal Natuurbewaringsraad is in wese die opvolger in titel van die Natalse Parkeraad en die Direkoraat Natuurbewaring. - (ii) 'n ongerehabiliteerde insolvente persoon is, of insolvent word en die insolvensie die sekwistrasie van sy of haar boedel tot gevolg het;
- (iii) deur die hof van die Republiek as geestelik versteurd verklaar is; of
- (iv) sedert die datum waarop die Grondwet in werking getree het aan 'n misdryf skuldig bevind is en tot gevangenisstraf vir 'n tydperk van meer as 12 maande sonder die keuse van 'n boete gevonnisd is, binne die Republiek, of buite die Republiek se grense ingevolge waarvan so 'n oortreding 'n misdryf in die Republiek sou wees, maar geeneen kan gereken word as gevonnisd voor 'n appel teen sodanige vonnis nie bepaal is nie, of voor die appel nie verstryk het nie. 'n Diskwalifikasie volgens die paragraaf eindig vyf jaar na die vonnis volstryk is.

Persone sal vir 'n tydperk van drie (3) jaar of sodanige korter tydperk as wat ek, BM Radebe, LUR vir Landbou en Omgewingsake ingevolge artikel 6 van die Wet mag bepaal, aangestel word.
