

PUBLIC CONSULTATION: INTENTION TO DECLARE NATURE RESERVES IN TERMS OF THE NATIONAL ENVIRONMENTAL MANAGEMENT: PROTECTED AREAS ACT, 2003 (ACT NO. 57 OF 2003);

Notice is hereby given by the MEC for Agriculture, Environmental Affairs in KwaZulu-Natal, the Honourable Dr Meshack Radebe, in terms of section 33(1); of the National Environmental Management: Protected Areas Act No. 57 of 2003 of the intention to declare following areas as a Nature Reserves and incorporate these into the existing Hlhuluwe-iMfolozi Game Reserve.

Area 2: - A portion of Reserve No. 11 No. 15831 – GU in extent approximately 2484.3821 hectares and owned by the Ingonyama Trust – Trustees under title deed T7097/2002. The area is situated south west of the Hluhluwe-Imfolozi Game Reserve and borders the White imfolozi River. The area falls under the custodianship of the Obuka Traditional Authority represented by iNkosi Biyela.

Area 3: - A portion of Fuleni Reserve No. 14375 – GU in extent approximately 2199.7747 hectares and owned by the Ingonyama Trust – Trustees under grant G26/1962. The area is situated south west of the Hluhluwe-Imfolozi Game Reserve. The area falls under the custodianship of the Somopho Traditional Authority represented by iNkosi Mthembu.

Area 5: - A portion of Portion 11 of Reserve No. 12 No. 15832 – HU in extent approximately 1208.1253 hectares and owned by the Ingonyama Trust – Trustees under title deed T70197/2002. The area is situated north west of the Hluhluwe-Imfolozi Game Reserve and borders the White Imfolozi River. The area falls under the custodianship of the Mandhlakazi Traditional Authority represented by iNkosi Zulu.
