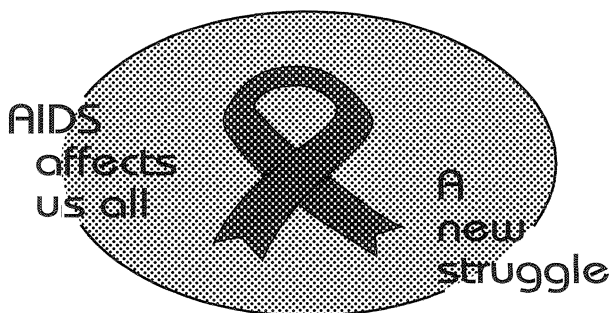

Should any Thursday coincide with a public holiday, the publication date remains unchanged.
