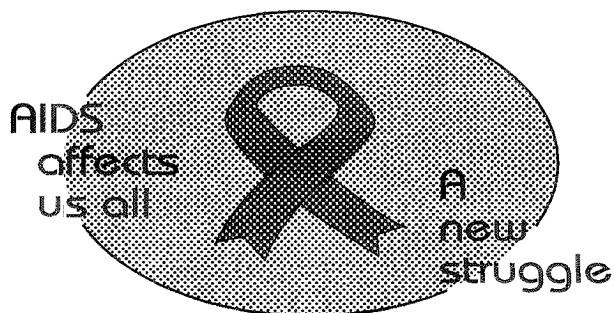

CLOSING TIMES FOR THE ACCEPTANCE OF NOTICES

1. (1) The *KwaZulu-Natal Provincial Gazette* is published every week on Thursday, and the closing time for the acceptance of notices which have to appear in the *KwaZulu-Natal Provincial Gazette* on any particular Thursday, is **15:00 one week prior to the publication date**. Should any Thursday coincide with a public holiday, the publication date remains unchanged. However, the closing date for acceptance of advertisements moves backwards accordingly, in order to allow for 5 working days prior to the publication date.
- (2) The date for the publication of an **Extraordinary** *KwaZulu-Natal Province Provincial Gazette* is negotiable.
2. (1) Notices received **after closing time** will be held over for publication in the next *KwaZulu-Natal Provincial Gazette*.
- (2) Amendments or changes in notices cannot be undertaken unless instructions are received **before 10:00 on Fridays**.
- (3) Notices for publication or amendments of original copy can not be accepted over the telephone and must be brought about by letter, by fax or by hand. The Government Printer will not be liable for any amendments done erroneously.
- (4) In the case of cancellations a refund of the cost of a notice will be considered only if the instruction to cancel has been received on or before the stipulated closing time as indicated in paragraph 2(2).

3. 

STATEMENT OF SIGNIFICANCE

Ndlela was the Chief Commander of the Zulu army between 1829 and 1840. He conducted a number of campaigns during the reign of King Dingane, including an attack on the Ndebele of Mzilikazi in the former Transvaal in 1832. He became a strong opponent of the growing European influx into Natal, and played a leading role in King Dingane's massacre of Piet Retief and his parties in 1838. He also led the Zulu army at the Battle of Blood River in 1838 and the Battle of Magudu in 1840. The Zulu army lost these two battles and King Dingane, suspicious of Ndlela's loyalty, had him executed.

The memorial is a symbolic acknowledgment of Ndlela, who played an important role in building the Zulu army in the 1830's, and whose strategic and leadership skills were unique and extraordinary.

STATEMENT OF SIGNIFICANCE

In 1906, Inkosi uSigananda kaZokufa Shezi joined forces with Inkosi uBhambatha kaManciza Zondi and protested against the imposition of poll tax. At the Battle of Mome Gorge on 10 June 1906 the Colonial forces defeated the protestors and Inkosi uSigananda was captured. He was later tried and condemned to death. He died on 22 July 1906, before the sentence could be carried out.

The memorial marks the gravesite of Inkosi uSigananda who, like Inkosi uBhambatha and others, stood firmly against colonial oppression.

STATEMENT OF SIGNIFICANCE

Chief Bhambatha ka Mancinza led the 1906 protest against the imposition of Poll-Tax on his people. The protest spread throughout Natal and Zululand before being crushed by the Colonial Forces in the Battle of Mome Gorge at INkandla Forest on 10 June 1906. The first skirmish was at Mpanza on 4 April 1906 and took place where this memorial stands. Bhambhatha was in charge of this ambush in which four police officers were killed. Three days after the ambush Colonial troops burnt his homestead and he escaped with his followers to Zululand. The Mpanza ambush was the start of a three month rebellion marked by confrontation between the Colonial Government and those who opposed it. It was this rebellion that also resulted in the second arrest and sentencing of King Dinizulu, to four years in prison, on charges of complicity.


