

A notice is to be served to each owner under the requirements of section 49 (1) (C) and Section 78(2) of the municipal Property Rates Act, 2004 (Act No.6 of 2004). The purpose of the notice is to advise you of the valuation placed on your property as determined during the General Roll, Municipal Notice No. 1928 Is the official notice advising you of your rights to view the General Valuation Roll and the process to follow to submit an objection.

All those Property Owners who have not supplied us with their postal address or notified us of their change of address are advised that should they not submit their objections by closing date of 27<sup>th</sup> May 2014, at 12h00, Council will not be held liable.

The General Valuation Roll will be open for inspection from the 2<sup>nd</sup> April 2014. The Valuation Roll can be inspected at the Umvoti Municipal Offices and will also be available on municipal website <a href="https://www.umvoti.gov.za">www.umvoti.gov.za</a>, Libraries and Museum.

An objection centre has been set up at the Umvoti Municipal offices to assist property owners with the completion and submission of objection forms, should you wish to complete and submit your objection form without assistance the objection forms are available on the website <a href="https://www.umvoti.gov.za">www.umvoti.gov.za</a>

The municipality will furnish each person liable for the payment of rates with a written account in terms of Section 27(1) of the Act. In terms of section 27(2) a person is liable for payment of rates whether or not that person has received a written account in terms of 27(1). If a person has not received a written account, that person must make the necessary enquiries from the municipality.
